Mr. WEEKS of Cumberland: Mr. President and Members of the Senate: All of you recognize this measure as being highly controversial. and I call your specific attention to the fact that Senator Silsby is not here and he did sign the minority report. When I came down this week I hoped that possibly we could get it off the calendar and get some action on it one way or another. Of course I do not know how the members feel and I have not attempted to find out. What I did have in mind — it may meet with your approval and it may not - was that possibly we might find out what people are thinking. Consequently if it would be the disposition of the Senate to accept the majority report and let it pass along one or two steps without prejudicing anyone's rights to oppose it at any time then there may be debate on it at some future step. I personally would favor that procedure and would like to have the rest of the Senate go along if you would. At no time do I want to prevent Senator Silsby or anyone else from saying what they feel about this bill. I do not know whether that is a proper suggestion. In other words, my idea is that we would not be debating it on more than one occasion. With that idea in mind, I move the acceptance of the majority "Ought to pass" report of the committee. By the way, I will state that I checked with Senator Dunham and he feels that Senator Silsby would not object if it is agreeable to the rest of the Senate.

Mr. BOUCHER of Androscoggin: Mr. President, I ask for a division.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Weeks, that the Senate accept

the majority "Ought to pass" report of the committee. The Senator from Androscoggin, Senator Boucher, has asked for a division. Is the Senate ready for the question?

As many as are in favor of the motion of the Senator from Cumberland, Senator Weeks, that the Senate accept the majority "Ought to pass" report of the committee will rise and stand until counted.

A division was had.

Eighteen having voted in the affirmative and nine in the negative, the motion prevailed and the majority "Ought to pass" report of the committee was accepted. The bill was thereupon given its first reading and tomorrow assigned for second reading.

The PRESIDENT: On behalf of the Senate, the Chair notes in the gallery a group of youngsters from Whitefield School, accompanied by Mrs. Neota Fowls Grady, former Representative in the House.
