Mr. COLLINS of Aroostook: Mr. President, out of order and under suspension of the rules I would request unanimous consent to introduce a bill. I would hesitate to do this at this late hour were it not for the fact that I think it is of general interest to all the members of the Legislature.

Since last week when the announcement came out about the Salk vaccine there has been tremendous interest in the continued treatment of polio, and the Governor in conference with Dr. Fisher has thought it appropriate that some additional money should be provided to buy vaccine. The vaccine that is furnished by the National Foundation will take care of the first two grades in the immunization shots that they give this spring, but next fall to continue with the third shots and to continue with the third and fourth grades and also to have a supply in case of emergency it would be necessary for the State to purchase some of the vaccine and the Department of Health and Welfare does not have the funds available for this particular purpose. That, in short, is the reason for the introduction of the bill. As I say, it is one that the Governor is particularly interested in, it is one that we as legislators should be interested in, and I hope it has consideration.

The PRESIDENT: The Senator from Aroostook, Senator Collins, out of order and under suspension of the rules, asks unanimous consent for the introduction of a bill.

On motion by Mr. Collins of Aroostook, out of order and under suspension of the rules the Senate voted to take from the table item under "Tabled for Chairman on Appropriations and Financial Affairs" matters, (S. P. 513) (L. D. 1404) "Resolve Reimbursing Certain Municipalities on Account of Property Tax Exemption of Veterans," tabled by that Senator on April 12th pending final passage. On further motion by the same Senator, the Senate voted to reconsider its action whereby the resolve was passed to be engrossed.

Mr. COLLINS of Aroostook: Mr. President, I now offer Senate Amendment "A" and move its adoption. I would say in explanation that this amendment puts in the exemption of one town which inadvertently did not get before the committee in time and which was brought to my attention just the other day. I move the adoption of Senate Amendment "A".

Senate Amendment "A" was read by the Secretary as follows:

SENATE AMENDMENT "A" to S. P. 513, L. D. 1404, Resolve Reimbursing Certain Municipalities on Account of Property Tax Exemptions of Veterans.

Amend said Resolve by striking out in the 3rd line thereof the figures "\$2,115.10" and inserting in place thereof the figures "\$2,373.13" Further amend said Resolve by adding at the end thereof the following: 'Springfield 258.30'

Senate Amendment "A" was adopted and the resolve was passed to be engrossed as amended.

Sent down for concurrence.

Mr. DURHAM of Hancock: Mr. President, I would like to inquire if S. P. 79, L. D. 178, "An Act Relating to Incurable Insanity as a Cause for which a Divorce may be Granted" is in the possession of the Senate?

The PRESIDENT: The Chair will state that S. P. 79, L. D. 178 is in the possession of the Senate.

Mr. DUNHAM: Mr. President and members of the Senate: I move that we reconsider our action whereby this bill was passed to be engrossed. My reason for doing that is that Senator Silsby who signed the minority report has been absent for the last two or three days and out of courtesy to him I think he should have the opportunity to present his side of the story, therefore I make that motion.

The PRESIDENT: The Chair would ask the Senator if he voted on the prevailing side?

Mr. DUNHAM: I did, Mr. President.

The PRESIDENT: The Senator from Hancock, Senator Dunham, moves that the Senate reconsider its action whereby the bill was passed to be engrossed. Is this the pleasure of the Senate?

The motion prevailed and reconsideration was voted.

On motion by Mr. Silsby of Hancock the bill was tabled pending passage to be engrossed.

On motion by Mr. Butler of Franklin, the Senate voted to take from the table House Report "Ought to pass" from the Committee on Claims on "Resolve in Favor of Harriett and George L. Christianson of Portland," (H. P. 38) (L. D. 1426) tabled by that Senator on April 8th pending acceptance of report.

Mr. BUTLER of Franklin: Mr. President, I do not like this principle any more than I did on some of the others but we have several which are already tabled involving

the same principle of liability of the State, and in order to facilitate the mechanical operations of the Legislature I move that the report of the committee be accepted.

The PRESIDENT: The Senator from Franklin, Senator Butler, moves that the Senate accept the "Ought to pass" report of the committee. Is this the pleasure of the Senate?

The motion prevailed and the "Ought to pass" report of the committee was accepted and the resolve was given its first reading.

Committee Amendment "A" was read by the Secretary as follows:

"Committee Amendment 'A' to H. P. 38, L. D. 1426, Resolve in Favor of Harriett and George L. Christianson of Portland."

"Amend said resolve by striking out in the second line thereof the figure \$250 and inserting in place the figure \$167.50."

Committee Amendment "A" was adopted and the resolve was tomorrow assigned for second reading.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table the 61st tabled and unassigned matter, (H. P. 946) (L. D. 1049) Bill "An Act to Permit Counties to Use Surplus Funds," tabled by that Senator on April 15th pending passage to be enacted; and on further motion by the same Senator the bill was passed to be enacted.

On motion by Mr. Butler of Franklin, the Senate voted to take from the table (H. P. 1175) (L. D. 1416) House Report "Ought to pass" from the Committee on Claims on "Resolve in Favor of Allie Cota of Gray," tabled by that Senator on April 20th pending acceptance of report.

Mr. BUTLER of Franklin: Mr. President, I do not like this measure any better than the other one, it is on the same principle, but in order to facilitate mechanical operations I move the acceptance of the report.

The motion prevailed and the "Ought to pass" report of the committee was accepted and the resolve was given its first reading and tomorrow assigned for second reading.

On motion by Mr. Dunham of Hancock, the Senate voted to take from the table the 62nd tabled and unassigned matter, (S. P. 427) (L. D. 1443) "Resolve in Favor of Leroy Foster of Amherst," tabled by that Senator on April 19th pending consideration.

The PRESIDENT: The Secretary will read the endorsements.

The SECRETARY: In the Senate on April 12th read a second time and passed to be engrossed.

Comes from the House on April 15th indefinitely postponed in nonconcurrence.

Mr. SILSBY of Hancock: Mr. President and members of the Senate. This is a resolve in favor of Leroy Foster of Amherst and for some unknown reason the papers got fouled up in the Agricultural Department on the matter of affidavit supporting the claim and after the matter was heard by the committee the affidavit was found and there is no purpose for this resolve and I now move that we recede and concur.

Thereupon the Senate voted to recede and concur with the House in the indefinite postponement of the resolve.

Mr. WEEKS of Cumberland: Mr. President and members of the Senate: I very reluctantly arise this morning to ask your indulgence to permit me to introduce a resolve by unanimous consent. For some reason or other a measure which has been something of a recurring nature in the past has been introduced whereby the Public Utilities Commission was authorized to buoy Sebago Lake. I do not have to describe Sebago Lake to you; it is a pretty big lake with an increasing number of boats and consequently increased hazards there. The Public Utilities Commission has buoyed it in times past. This bill authorizes them to do it again and also calls for a six hundred dollar appropriation from the general fund to take care of it. I believe it is something that has happened in the past.

The PRESIDENT: The Senator from Cumberland, Senator Weeks, asks unanimous consent for the introduction of a resolve. The Secretary will read the resolve by title only.

The SECRETARY: "Resolve authorizing Maine Public Utilities Commission to set out and maintain buoys on Sebago Lake."

The PRESIDENT: Is there objection to the reception of the resolve? The Chair hears none and the resolve is received.

Mr. WEEKS: Mr. President, I move that the resolve be referred to the Committee on Public Utilities.

The PRESIDENT: The Chair would note that the normal reference by the Committee on Reference of Bills would be to the Committee on Appropriations and Financial Affairs.

Mr. WEEKS: Mr. President, I specifically mentioned that committee because I was a little in doubt as to just which one to suggest. I assumed Senator Collins would have it under his thumb at some time.

The PRESIDENT: Would the Senator from Cumberland care to ask the Senator from Aroostook, Senator Collins to make a motion on reference?

Mr. WEEKS: Mr. President, I would be delighted to have the Senator do so.

On motion by Mr. Collins of Aroostook the resolve was referred to the Committee on Appropriations and Financial Affairs, ordered printed and sent down for concurrence.

On further motion by Mr. Weeks of Cumberland the resolve was ordered sent forthwith to the House.

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table Senate Reports from the Committee on Judiciary; Majority Report "Ought not to pass", Minority Report "Ought to pass" on Bill "An Act Relating to Itemized Statements Filed by Legislative Counsel and Agents." (S. P. 246) (L. D. 679) tabled by that Senator on March 17 pending consideration of the reports.

Mr. REID of Kennebec: Mr. President, with the understanding that a Senator has an amendment to offer, I now move that the Minority report "Ought to pass" be accepted. The motion prevailed, the Minority report "Ought to pass" was accepted and the bill read once.

Mr. Farley of York presented Senate Amendment A and moved its adoption.

SENATE AMENDMENT "A" to S. P. 246, L. D. 679, Bill "An Act Relating to Itemized Statements Filed by Legislative Counsel and Agents."

Amend said Bill by striking out all after the enacting clause and inserting in place thereof the following:

'Sec. 37-A. Statements. Everv legislative counsel or agent shall file with the Secretary of State during the first week of each month of each legislative session, including first week of the month following final adjournment, an itemized statement under oath of his expenditures during the preceding month in connection with such legislative employment and by whom paid or to whom charged, excepting, however, his personal living and travel expenses. Such statements shall be in such form as the Secretary of State may prescribe and shall be open to public inspection.'

Which amendment was adopted and the bill as amended was tomorrow assigned for second reading.

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table "Resolve in Favor of Raymond Butler of New Gloucester" (H. P. 37) (L. D. 1422) tabled by that Senator on April 12 pending passage to be engrossed; and on further motion by the same Senator, the resolve was passed to be engrossed in concurrence.

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table "Resolve in Favor of Cyril Swallow of South Paris." (H. P. 95) (L. D. 1421) tabled by that Senator on April 12 pending passage to be engrossed; and on further motion by the same Senator, the resolve was passed to be engrossed in concurrence.

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table "Resolve in Favor of Robert S. Robinson of Westbrook" (H. P. 252) (L. D. 1423) tabled by that

Senator on April 12 pending passage to be engrossed; and on further motion by the same Senator, the resolve was passed to be engrossed.

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table "Resolve in Favor of Philip Krisilos of Portland" (H. P. 291) L, D. 1424) tabled by that Senator on April 12 pending passage to be engrossed; and on further motion by the same Senator, the resolve was passed to be engrossed in concurrence.

On motion by Mr. Fuller of Oxford
