Thursday, April 28, 1955

Senate called to order by the President.

Prayer by Rev. Howard O. Hough of Portland.

Journal of yesterday read and approved.

# Papers from the House

Bill "An Act Relating to Pensions for Dependents of Deceased Policemen of City of Lewiston." (S. P. 163) (L. D. 357)

In Senate on April 5, passed to be engrossed.

Comes from the House, referred to the next Legislature, in non-concurrence.

In the Senate, on motion by Mr. Lessard of Androscoggin, that Body voted to insist on its former action and ask for a Committee of Conference.

### After Recess

The Senate was called to order by the President.

Mr. WOODCOCK of Penobscot: Mr. President, under suspension of the rules, I asked unanimous consent to introduce a bill.

Thereupon, out of order and under suspension of the rules, bill An Act Relating to Legal Obligations of the Town of Eddington School District, was received by unanimous consent.

Mr. WOODCOCK of Penobscot: Mr. President, earlier in the present session there was a Town of Eddington School District bill introduced by the present speaker and that went through the committee and the House and Senate and was signed by the Governor. Since that time it has come to the attention of some of us that by inadvertence there was one sentence left out of that School District bill which is in most of the measures and it is possible it might cause a little trouble later on in the marketing of the bonds if it were not added. The original bill is now in the laws of Maine, and this bill if allowed to come in through the House and Senate would rectify that possibly troublesome matter.

I would move now, Mr. President, under suspension of the rules the first reading of the bill without reference to a committee.

The motion prevailed and under suspension of the rules, the bill was given its two several readings without reference to a Joint Standing Committee and was passed to be engrossed.

Sent down for concurrence.

The Chair laid before the Senate the first tabled and especially assigned matter being House Reports from the Committee on Appropriations and Financial Affairs: Majority Report "Ought to pass" in new draft under New Title as "An act to Create the Department of Development of Industry and Commerce (H. P. 1196); Minority Report "Ought not to pass" on bill, "An Act to Create the Department of Industry and Commerce and to Amend the Laws Relating to the Department of Labor and Industry and Maine Development Commission to Conform Thereto" (H. P. 514) (L. D. 620) tabled by the Senator from Aroostook, Senator Collins on April 27 pending acceptance of either report.

Mr. COLLINS of Aroostook: Mr. President and members of the Senate: In view of the fact that the hour is getting rather late and that this bill requires considerable consideration, I am going to ask the indulgence of the Senate to retable this bill again and not assign it for a specific day because I think that some of the members of the Senate want to give it further study. I will be perfectly willing to take it from the table at such time as I feel that enough of the Senators have completed their study of it.

The bill was thereupon tabled pending acceptance of either report.

Mr. JAMIESON of Aroostook: Mr. President, I would ask if L. D. 957 is in the possession of the Senate?

The PRESIDENT: The Chair will state that the document is in the possession of the Senate having been held at the request of the Senate to r from Aroostook, Senator Jamieson.

Mr. JAMIESON of Aroostook: Mr. President, I move that the Senate reconsider its action whereby the bill was passed to be engrossed.

Mr. FARRIS of Kennebec: Mr. President, will the Secretary please read the title of the bill so everyone will know what it is about?

The SECRETARY: S. P. 348, L. D. 957, bill, "An Act to Clarify the Employment Security Law."

Mr. FARRIS of Kennebec: Mr. President, this is a bill that primarily is a departmental bill, a long bill, and the purpose of the bill was to clarify certain laws pertaining to our Unemployment Security set-up. There are other bills to come along, and if there is anything objectionable in the present bill or matters that are objectionable to the members of industry that are up here there will be plenty of opportunity to make amendments and corrections and to debate the issue at that time. I am opposed to reconsidering our action of yesterday and feel that we should get at least one bill out of the Labor Committee pertaining to unemployment laws and on its way and not have five or six bills which we have to watch on the Labor Committee, or amendments which the industrial lobby want to add to them. I am opposed to the motion for reconsideration.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Aroostook, Senator Jamieson, that the Senate reconsider its action whereby the bill was passed to be engrossed.

Mr. REID of Kennebec: Mr. President, I ask for a division.

Mr. PARKER of Piscataquis: Mr. President, I am not sure I understand which bill this is. I understood it was L. D. 950

The PRESIDENT: L. D. 957.

Mr. PARKER: Mr. President, I think we should all thoroughly understand this bill. I am certainly willing to be counted, but I am not sure just what this bill calls for.

Mr. JAMIESON: Mr. President, I ask unanimous consent to address the Senate.

The PRESIDENT: The motion is debatable.

Mr. JAMIESON: Mr. President, the reason that I asked for reconsideration is that there are sections in that bill that I really believe are not acceptable to either labor or industry, and my purpose when I asked for reconsideration was to have the bill tabled and we could take it up with labor and industry and come out with something that would be satisfactory to both. That was my purpose. I did not have any intention of slowing up the progress of the bill or anything: I just wanted to be sure it was satisfactory to both labor and industry.

Mr. CHAPMAN of Cumberland: Mr. President, I move that the bill and accompanying papers be laid on the table and assigned especially for tomorrow morning pending the motion to reconsider.

The PRESIDENT: The Senator from Cumberland, Senator Chapman, moves that the bill and accompanying papers be laid on the table pending the motion of the Senator from Aroostook, Senator Jamieson, that the Senate reconsider its action whereby the bill was passed to be engrossed.

Mr. FARRIS of Kennebec: Mr. President, I rise solely on a point of order and for information. Would a motion to lay this document upon the table be in order where it has

already been passed to be engrossed?

The PRESIDENT: The Chair will note that the motion before the Senate is the motion of the Senator from Aroostook, Senator Jamieson, that the Senate reconsider its action whereby the bill was passed to be engrossed. A motion to lay it on the table pending the motion of the Senator from Aroostook, Senator Jamieson, the Chair rules is in order.

Mr. FARRIS: Mr. President — The PRESIDENT: For what purpose does the gentleman rise?

Mr. FARRIS: To ask for a division on this tabling motion. I would like to state —

The PRESIDENT: The Senator may ask unanimous consent, a courtesy that the Senate usually extends.

Mr. FARRIS: Mr. President, it is not in order to debate a tabling motion, but there are very good reasons why I request a division.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Chapman, that the bill and accompanying papers be laid upon the table pending the motion of the Senator from Aroostook, Senator Jamieson, that the Senate reconsider its action whereby the bill was passed to be engrossed. The Senator from Kennebec, Senator Farris, has asked for a division.

As many as are in favor of the motion of the Senator from Cumberland, Senator Chapman, will rise and stand until counted.

A division was had.

The PRESIDENT: Twenty-six having voted in the affirmative and two in the negative, the motion prevails and the bill is tabled and especially assigned for tomorrow pending the motion of the Senator from Aroostook, Senator Jamieson to reconsider.

On motion by Mr. Silsby of Hancock, the Senate voted to reconsider its action of this morning whereby Bill "An Act relating to Preference in State Purchases for Products Raised or Manufactured in State" (H. P. 924) (L. D. 1032) was passed to be enacted, and on further motion by the same Senator the

matter was tabled pending passage to be enacted.

On motion by Mr. Cole of Waldo, the Senate voted to reconsider its action of this morning whereby Bill "An Act Relating to Fees for Motor Vehicle Inspections" (S. P. 235) (L. D. 571) was passed to be engrossed, and on further motion by the same Senator the bill and accompanying papers were tabled pending passage to be engrossed.

On motion by Mr. Chapman of Cumberland, the Senate voted to take from the table "Resolve Proposing an Amendment to the Constitution Extending Pardon Powers of Governor and Council to Offenses of Juvenile Delinquency," (S. P. 429) (L. D. 1118) tabled by that Senator earlier in today's session pending final passage.

Mr. CHAPMAN: Mr. President, I now move that we reconsider our former action whereby this resolve was passed to be engrossed, and my purpose in requesting reconsideration is to allow the presentation of a perfecting amendment.

a perfecting amendment.

The motion prevailed. Mr. Chapman then offered Senate Amendment "A" and moved its adoption. Senate Amendment "A" was read by the Secretary as follows:

"Senate Amendment 'A' to Resolve Proposing an Amendment to the Constitution Extending Pardon Powers of Governor and Council to Offenses of Juvenile Delinquency," (S. P. 429) (L. D. 1118)

Amend said resolve by striking out the underlined words 'applied to' in the 9th line thereof and inserting in place thereof the underlined word 'include'"

Mr. CHAPMAN: Mr. President, in requesting the adoption of this amendment I will say just very briefly that the text of it has been cleared with the committee. It does not affect the objective of the resolve. The perfecting feature to justify this amendment was something that the Attorney General's Department thought was rather desirous to be done to the resolve.

Senate Amendment "A" was adopted and the resolve was passed to be engrossed as amended by Senate Amendment "A".
