Orders of the Day

The gentleman from Bath, Mr. Ross, was granted unanimous consent to address the House.

Mr. ROSS: Mr. Speaker and Members of the House: Yesterday morning there was a meeting of the House Chairmen of all Committees. It was suggested and discussed at some length that for the next few weeks to expedite our proceedings we have afternoon sessions on Wednesday commencing at one o'clock instead of ten o'clock in the morning.

This would allow two groups of hearings on that day. Hearings could commence at ten o'clock in the morning, then we would have our meeting at one o'clock in the afternoon and more hearings at twothirty. Not only would this get in more hearings, but it would help in preventing conflicts for people who have two or more committees or people who have bills of their own to be heard; and further, it would give more people who come from farther away more of an opportunity to sit in at our hearings and also observe our legislative proceedings.

The Chairmen voted unanimously to go along with this suggestion for about four weeks starting next week. Now unfortunately, because of a prior commitment of the Appropriations Committee which has a hearing on the University of Maine that not only is a very important hearing but will be very well attended, and furthermore incorporates certain social functions such as a tea for which the plans have already been made; so it is impossible to start this schedule next week, but tentatively we are

planning to start the week after with Wednesday afternoon sessions instead of Wednesday morning. Thank you very much. On motion of Mr. Beyer of Cape Elizabeth,
