HOUSE

Thursday, February 7, 1957

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Harvey Ammerman of Augusta.

The journal of the previous session was read and approved.

The gentleman from Lewiston, Mr. Jalbert, was granted unanimous consent to address the House.

Mr. JALBERT: Mr. Speaker and Members of the House: Under suspension of the rules, I would like to have taken up at this time an enactor on page six of the calendar, An Act to Create the Lewiston Parking District, and ask to speak very briefly on the measure.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, moves that out of order and under suspension of the rules Item two on page six of the calendar under enactors be placed before the House at this time.

The motion prevailed.

The gentleman from Lewiston, Mr. Jalbert, was granted unanimous consent to address the House.

Mr. JALBERT: Mr. Speaker, I would move that this measure be finally passed, enacted and, in defense of that motion, I would state that this bill has an emergency preamble on it. It also has a referendum clause on it. Basically, certainly due to the referendum clause. the entire Lewiston delegation is in accord, which is also refreshing. We have an election a week from Monday and, in order to have this matter placed upon the ballots for the electorate of Lewiston, it would have to be enacted today in both branches and signed by the Governor should it receive passage.

Therefore, I move that it be enacted and also move that it be sent forthwith to the Senate out of order and under suspension of the rules. Thank you very much.

Passed to Be Enacted Emergency Measure

An Act to Create the Lewiston Parking District (H. P. 75) (L. D. 102)
