#### HOUSE

Wednesday, February 13, 1957

The House met according to adjournment and was called to order by the Clerk, Harvey R. Pease.

Prayer by Captain Ash of the Salvation Army, Augusta.

In accordance with the rules, the House proceeded to choose a Speaker pro tempore and the following committee was appointed to receive,

sort and count votes:

Messrs. BROWNE of Bangor ROSS of Brownville STORM of Sherman MATHIESON of Montville

Mrs. CHRISTIE of Presque Isle Messrs. LETOURNEAU of Sanford EDWARDS of Raymond

The CLERK: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: I will inquire from the Chair, it wouldn't be proper on such an occasion as this to make a nomination from the floor for the purpose of some member of the House to act as Speaker pro tem when the Speaker is not present?

The CLERK: The Chair would hesitate to recognize for that purpose, it is contrary to the precedence of the House. However, it is within the province of the House to decide how they will choose a Speaker pro tem.

The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Chairman, whereas this is an honor which would be bestowed upon people on very, very rare occasions, I think that it would be a nice gesture on members of the House that if each and every day that the House Speaker is not here to give some other member of the House an opportunity to act as Speaker pro tem, so therefore I would request that the members of the House place it open to nominations.

The CLERK: Does the Chair understand that the gentleman from Portland moves that the House in choosing a Speaker pro tem first accept nominations for that position? The gentleman from Portland, Mr. Childs, has moved that in choosing a Speaker pro tem that nomina-

tions be made from the floor for that position. Is there any discussion on that motion? The Chair hears none. Is this the pleasure of the House?

The motion prevailed.

The CLERK: The Chair recognizes the gentleman from Charleston, Mr. Rich.

Mr. RICH: Mr. Chairman, I would like to place in nomination the name of Dana Childs for temporary Speaker today.

The CLERK: The gentleman from Charleston, Mr. Rich, places in nomination the name of the gentleman from Portland, Mr. Childs. Are there any other nominations?

The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: I would like to place to the members of the House for the purpose of Speaker pro tem for today the name of Steven Shaw from Bingham. If I may, if I am not out of order, I request that my name be withdrawn.

The CLERK: The gentleman from Portland, Mr. Childs, has placed in nomination the name of Steven Shaw.

The Chair recognizes the gentleman from Bath, Mr. Couture.

Mr. COUTURE: Mr. Chairman, I would like to place in nomination the name of Rodney E. Ross, Jr. for Speaker pro tem today.

The CLERK: The gentleman from Bath, Mr. Couture, places the name of Rodney E. Ross in nomination for Speaker pro tem.

The Chair recognizes the gentleman from Bath, Mr. Ross.

Mr. ROSS: Mr. Chairman, I appreciate my name being suggested. I would also like to withdraw. I would like to make a comment though. I think perhaps it is a good idea if our Speaker is going to be absent for any length of time to alternate the Speaker pro tem, but knowing the difficulty in the procedure that goes on and the preparation that must be made ahead of time, it would seem to me rather difficult on the spur of the moment for a Speaker pro tem to take over the whole morning's procedure and handle the situation orderly. So, at this time I would like to place in nomination the name of the gentleman from Bangor, Mr. Totman.

The CLERK: The gentleman from Bath, Mr. Ross, places in nomination the name of the gentleman from Bangor, Mr. Totman.

The Chair now recognizes the gentleman from Cumberland, Mr. Call.

Mr. CALL: Mr. Chairman and Members of the House: I deeply appreciate, as well as the rest of you, following parliamentary procedure as my good friend, Mr. Childs from Portland, has brought up this morning. Whereas the Speaker of the House is now ill, to save time, that we have a majority floor leader. I think it is only fitting, during the illness of the Speaker, that we should continue as we started yesterday, primarily to save time.

In the course of the Legislature many of you people will be asked to be Speaker pro tem, an honor will be conferred upon you. That honor has been conferred in the past on some of the older members.

I now move and second the motion that the gentleman from Bangor, Mr. Totman, be Speaker pro tem for the next two days during the illness of our Speaker, primarily to save time.

The CLERK: The Chair hears the motion of the gentleman from Cumberland, Mr. Call, and in view of the meaning of the House Rules, the Chair will have to rule that the motion is not in order. The Chair recognizes the gentleman from Bingham, Mr. Shaw.

Mr. SHAW: I am quite complimented by the nomination this morning, but I would withdraw in favor of the gentleman from Bangor, Mr. Totman.

The CLERK: The House has heard the statement of the gentleman from Bingham, Mr. Shaw.

The Chair recognizes the gentleman from Chelsea, Mr. Allen.

Mr. ALLEN: I move that the Committee be instructed to cast one ballot for the gentleman from Bangor, Mr. Totman.

The CLERK: The gentleman from Chelsea, Mr. Allen, has moved that the Committee be instructed to cast the ballot of the House for the gentleman from Bangor, Mr. Totman. For what purpose does the gentleman arise?

Mr. CHILDS: I rise for a point of inquiry. I believe that the next

order of business should be that of having nominations cease, and therefore, where there is only one candidate at this time, I will now move at this time that nominations cease.

The CLERK: The gentleman from Portland, Mr. Childs, moves that nominations cease. The Chair understands that the House so votes. The gentleman from Chelsea, Mr. Allen, has moved that the Committee cast the vote of the House for Speaker pro tem for the gentleman from Bangor, Mr. Totman. Is that the pleasure of the House?

The motion prevailed.

The Committee subsequently reported:

The SPEAKER pro tem: I think it is only proper that as Speaker pro tem, I give you a report on your Speaker's condition. We will have a later order this morning expressing sympathies. He is improving and his wife has even gone to the extent of saying that she is sure he is much better because he is well enough now to start arguing.

The journal of the previous session was read and approved.

WHEREAS, the Ninety-eighth Legislature indicates its pleasure and desire that the alterations presently being carried on in the State House be of such a nature that the beauty and dignity of the State House shall be maintained, and

WHEREAS, Consistent with the above expressed desire, the Ninety-eighth Legislature believes that the installation of "smoke doors" on the second and third floors of the State House would substantially mar the dignity and beauty of the building, and

WHEREAS, for over a century the State House has properly functioned

without such "smoke doors," even though space was inadequate to properly care for State employees permanently housed in the building, and installation of such smoke doors after the passage of over a hundred years, and after relocation of numerous employees in the new State Office Building, seems to be a gesture, having little or no justification, be it therefore

ORDERED, that the Governor and Council, the Superintendent of Public Buildings, and the Insurance Commissioner be advised that it is the recommendation of the Ninety-eighth Legislature that the aforementioned "smoke doors" not be installed on the second and third floors of the State House.

It is hereby directed that copies of this Order be sent to the Governor, the Executive Council, the Superintendent of Public Buildings, and the Insurance Commissioner (S. P. 250)

The SPEAKER pro tem: The
Chair recognizes the gentleman
from Bath, Mr. Ross.

Mr. ROSS: Mr. Speaker, not only do I concur with the esthetic reasons contained in this paper for doing away with smoke doors, but aside from these reasons of dignity and beauty I think we as the House ought to point out one safety factor.

We are in the process of constructing two outside fire escapes, one will be in the rear of the House and another in the Senate. When these are completed the danger of anyone being trapped in either the House or the Senate without means of egress will be eliminated. I now move we now concur with the Senate.
