# Passed to Be Enacted Emergency Measure

An Act to Authorize the Town of Brunswick to Provide for the Collection and Disposal of Garbage and Rubbish (H. P. 137) (L. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a division was had. 132 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

# Orders of the Day

The gentleman from Cumberland, Mr. Call, was granted unanimous consent to address the House.

Mr. CALL: Mr. Speaker and Members of the House: I may not act it but I assure you I look it. Today I am celebrating with the happy Mrs. my thirty-sixth wedding anniversary. Briefly, a friend of mine wanted to put it in as an order, but I said: "I have been taking orders enough, and this is one time I am going to have something to say."

I want to take this occasion, Mr. Speaker, to thank you for allowing my grandson, Jimmy Wiles, who is here with us for the next three days, to obtain some knowledge of the sessions that he may attain a merit badge in the Scouts, and I want to thank the Chair for allowing him to sit in the well of the House during this procedure. Thank you.

The gentlewoman from Lovell, Mrs. Harriman, was granted unanimous consent to address the House.

Mrs. HARRIMAN: Mr. Speaker and Members of the House: I wish to say thank you for the lovely flowers that I received while I was at the Augusta General Hospital. I was sorry to have missed the Valentine Party, and particularly the presentation of my corsage with the accompanying caress. And might I suggest to the gentleman who was to bestow it that, if it is to be a delayed action, would he wait until I recover from this paralysis of the face so that we might thoroughly enjoy it.

The gentleman from Madison, Mr. Hendsbee, was granted unanimous consent to address the House.

Mr. HENDSBEE: Mr. Speaker, Members of the Legislature, and friends: Last Sunday in the supplement Parade Magazine of the Portland Sunday Telegram, there appeared a very startling piece of news. It concerns cystic fibrosis, the dread killer of small children. This item did not look too startling to me at the time, until I made some inquiries and found in my town we have one family with three children afflicted with this disease. On inquiring, I have found that the father has many times had to leave Madison at night and get his child to the Children's Hospital in Boston in time to save its life.

This has been going on for quite some time, and at an early period I propose to present some legislation to take care of the matter of this type. I believe this is not an individual problem of mine or his or the Town of Madison, but I believe it concerns each and every one of us, because as having been a member of the Boy Scouts since 1912, my work has been mostly with young people. And our good Lord said, "Suffer little children to come unto me, for such is the Kingdom of Heaven."

I believe we should remember, before I say this last statement, I am going to leave this in the Library so that anybody interested may look it over and give me any thought that you have on the matter, and there is a very old and true saying that "There is no man stands so high as when he stoops to help a child." Thank you. (Applause)

The gentleman from Portland, Mr. Maynard, was granted unanimous consent to address the House.

Mr. MAYNARD: Mr. Speaker and Members of the House: At this time I would like to lean a bit on your patience to give me unanimous consent to introduce a bill that has reference to teachers' colleges. There is so much merit in the bill that I am sure that the discussion would be very profitable.

The SPEAKER: The gentleman from Portland, Mr. Maynard, now moves that he be granted permission to introduce a bill notwithstanding the cloture order. The Clerk will read the title of the bill.

The CLERK: Bill "An Act to Authorize Construction and Installation of Certain Capital Improvements at the State Teachers' Colleges and the Fort Kent State Normal School".

The SPEAKER: In order for the introduction of the bill under these circumstances, unanimous consent is necessary. Is there objection in the House to the gentleman from Portland, Mr. Maynard, introducing the bill notwithstanding the cloture order?

The Chair hears none and the Bill is received.

Thereupon, on motion of the gentleman from Portland, Mr. Maynard, the Bill (H. P. 634) was referred to the Committee on Appropriations and Financial Affairs, ordered printed and sent up for concurrence.

The gentleman from Lewiston, Mr. Cote, was granted unanimous consent to address the House.

Mr. COTE: Mr. Speaker and fellow members: I feel that I would be very remiss indeed if I failed in noting and bringing to the attention of the Members of the House that three of my colleagues from Lewiston were reelected to office yesterday, Representative Rancourt to his second term as Mayor, Representative Jacques to his fourth term as Alderman, and Representative Couture to his fifth term as Alderman. I would personally like to congratulate them and hope that all members of the House join me in wishing them a fruitful administration. Thank you. (Applause)

The SPEAKER: The Chair understands, in the absence of your Speaker last week, a joint order was passed to appoint three members of this House to a joint committee to be known as the Committee on Street Parking. This Committee shall be charged with the responsibility of meeting with the appropriate City of Augusta officials and the

officials of the Augusta Parking District to discuss such problems as may exist in the use of Augusta streets. In pursuance of that order, the Chair will now appoint as the three House members of that committee the following:

WALSH of Brunswick QUINN of Bangor EMMONS of Kennebunk

The gentleman from Bangor, Mr. Totman, was granted unanimous consent to address the House.

Mr. TOTMAN: Mr. Speaker and Members of the House; I have been asked on behalf of the Director of Legislative Research to call to your attention the fact that if some members are carrying in their pockets or have in their possession bills that have been prepared, and I certainly want to emphasize the distinction between a bill that has been prepared and a bill that is still in your mind.

For those members who have bills that have been prepared, and already have the name of the Director of Legislative Research on the jacket, the list of bills is being left open this afternoon until four o'clock. And it is suggested and respectfully requested that you take those bills out of your pocket and take them into Mr. Slosberg's office. However, I do want to emphasize this does not mean any breaking of the cloture date. This does not mean if you have not yet given the title or the contents of a bill to Mr. Slosberg, the door is still open. This is solely for bills that have already been prepared but which you for some reason have taken out of his office and have in your pocket. Thank you.
