HOUSE

Wednesday, February 27, 1957

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Donald Taylor of Second Baptist Church, Bowdoinham.

The journal of the previous session was read and approved.

Mr. Brewer of Caribou was granted unanimous consent to address the House.

Mr. BREWER: Mr. Speaker, I ask unanimous consent to address the House on a matter of vital concern to my home town, concerning a bill on the Calendar for enactment today.

The SPEAKER: Is there opposition to the request of the gentleman from Caribou, Mr. Brewer? The Chair hears none. The gentleman may proceed.

Mr. BREWER: Mr. Speaker, last night, a mistake was discovered in the Emergency Clause at the end of an Act to Establish Representative Town Meetings in the Town of Caribou, H. P. 92, L. D. 132, which is the third Enactor on the Advance Journal this morning. It has been determined that it is necessary to have the Act amended. It is also very necessary that the Bill be enacted and presented to the Governor this week for his approval in order that the citizens of Caribou may vote upon the measure at our annual Town Meeting. I therefore ask unanimous consent that Item 3 under Enactors, H. P. 92, L. D. 132, be taken up out of order at this time.

The SPEAKER: Is there objection to the request of the gentleman from Caribou, Mr. Brewer, that an Act to Establish Representative Town Meetings in the Town of Caribou be taken up at this time? The Chair hears none.

The Clerk read the title of the Enactor.

The SPEAKER: The Chair recognizes the same gentleman.

Mr. BREWER: Mr. Speaker, I now move under suspension of the rules, that the House reconsider its action of Thursday last whereby this measure was passed to be engrossed.

The SPEAKER: The gentleman from Caribou, Mr. Brewer, moves that under suspension of the rules the House reconsider its action of Thursday last whereby House Paper 92, Legislative Document 132, An Act to Establish Representative Town Meetings in the Town of Caribou was passed to be engrossed. Is this the pleasure of the House?

The motion prevailed.

Mr. BREWER: Mr. Speaker, I now offer House Amendment "A".

The SPEAKER: The gentleman from Caribou, Mr. Brewer, offers House Amendment A. The Clerk will read the amendment.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 92, L. D. 132, Bill, "An Act to Establish Representative Town Meetings in the Town of Caribou."

Amend said Bill by striking out all of "Sec. 11" and inserting in place thereof the following:

'Sec. 11. Emergency clause; effective date; referendum. In view of the emergency cited in the preamble, this Act shall take effect when approved, only for the purpose of permitting its submission to the legal voters of the town of Caribou at the next annual or a special town meeting to be held on or before July 1, 1957. The vote shall be taken by ballot in answer to the question: "Shall 'An Act to Establish Representative Town Meetings in the Town of Caribou,' passed by the 98th Legislature, be accepted?" The question shall be printed on the official ballot, and the voters shall indicate by a cross or check mark placed against the words "Yes" "No" their opinion of the same. This Act shall take effect for all the purposes hereof immediately upon its acceptance by a majority of the legal voters voting at said town meeting; provided that the total number of votes east for and against the acceptance of this Act equals or exceeds 25 per cent of the total vote for all candidates for Governor cast in said town at the next previous gubernatorial election.

The result of the vote shall be declared by the municipal officers of the town of Caribou and due certificate thereof shall be filed by the town clerk with the Secretary of State.'

House Amendment "A" was adopted.

The SPEAKER: Is it now the pleasure of the House that this Bill shall be passed to be engrossed as amended by House Amendment "A" in non-concurrence?

This Bill, having had its three several readings in the House and the Committee on Bills in the Third Reading having reported that no further verbal amendments are necessary, it is now the pleasure of the House that this Bill shall be passed to be engrossed in non-concurrence as amended by House Amendment "A"?

The motion prevailed and on further motion of the gentleman from Caribou, Mr. Brewer, the Bill was sent forthwith to the Senate.

House Amendment "A" was read

HOUSE AMENDMENT "A" to H. P. 78, L. D. 104, Bill, "An Act Providing for Group Life Insurance for Certain Members of the State Police."

Amend said Bill by inserting in place of the Enacting Clause, the following Emergency Preamble:

Emergency Preamble. Whereas, the usual effective date for legislative acts is several months hence; and

Whereas, life insurance can be extended only to living persons; and Whereas, the uncertainties of life may cause hardship to the family of any officer or trooper who may die prior to the usual effective date;

and
Whereas, in the judgment of
the Legislature these facts create
an emergency within the meaning
of the Constitution of Maine and require the following legislation as
immediately necessary for the preservation of the public peace, health
and safety; now therefore, be it enacted by the People of the State of
Maine, as follows:

Further amend said Bill by adding to the end thereof, the following Emergency Clause:

'Emergency Clause. In view of the emergency cited in the preamble, this act shall take effect when approved.'

Further amend said Bill by inserting in the 8th line thereof, after the underlined words "State Police Retirement System", the following underlined words: "including those members of that system who have retired since September 5, 1955 and are living at the effective date of this amendment. Notwithstanding

anything to the contrary the amount of group life insurance for said retired members of the State Police Retirement System shall be as set forth in Table A and shall be based upon the gross salary of each member at date of his retirement and shall reduce at the rate of 15 per cent per year from date of retirement as provided in Section 24 subsection IX A, all of whom'

House Amendment "A" was adopted and the Bill was passed to be engrossed as amended by House Amendment "A" and sent up for concurrence

The SPEAKER: The Chair now lays before the House the second tabled and today assigned matter, Bill "An Act relating to Definition of Public School Under State Retirement System", House Paper 142, Legislative Document 180, tabled on February 19 by the gentleman from Bangor, Mr. Quinn, pending passage to be engrossed, and the Chair recognizes that gentleman.

Thereupon, on motion of Mr. Quinn of Bangor, the Bill was recommitted to the Committee on Retirements and Pensions and sent up for concurrence.

The SPEAKER: The Chair now lays before the House the third tabled and today assigned matter, House Report "Ought to pass" of the Committee on Inland Fisheries and Game on Resolve Regulating Fishing in Moosehead Lake Tributaries, Somerset and Piscataquis Counties, House Paper 126, Legislative Document 164, tabled on February 20 by the gentleman from Madison, Mr. Hendsbee, pending acceptance of the Report.

The Chair recognizes the gentleman from Greenville, Mr. Harris.

Mr. HARRIS: Mr. Speaker, I move Item 3 be retabled and unassigned.

The SPEAKER: The gentleman from Greenville, Mr. Harris, moves that the Report and Resolve be retabled and unassigned. Is this the pleasure of the House?

Thereupon, on motion of the same gentleman, the Resolve (H. P. 736) was referred to the Committee on Retirements and Pensions, ordered printed and sent up for concurrence.

Mr. Carter of Newport was granted unanimous consent to address the House.

Mr. CARTER: Mr. Speaker, I would like to introduce a resolve at this time in favor of the Town of Stetson, notwithstanding the cloture order.

The SPEAKER: The gentleman from Newport, Mr. Carter, requests unanimous consent to introduce a Resolve at this time notwithstanding the cloture order. The Clerk will read the title of the Resolve.

The CLERK: Resolve to Reimburse Town of Stetson for Aid to Carlton Johnson and Family.

The SPEAKER: The gentleman from Newport, Mr. Carter, requests that this resolve be received notwithstanding the cloture order. Does the Chair hear objection? The Chair hears none and the resolve is received.

Thereupon, on motion of the same gentleman, the Resolve (H. P. 737) was referred to the Committee on Claims, ordered printed, and sent up for concurrence.

The gentleman from Bangor, Mr. Totman, was granted unanimous consent to address the House.

Mr. TOTMAN: Mr. Speaker and Members of the House: I feel it is only fair to make some comment now that we are approaching the end of our second week after cloture date, to advise that while we certainly wish to assist members who have serious emergency measures to introduce, particularly those that affect towns, it does seem that if there is going to be any merit in our cloture date, the time is fast approaching when I suspect some members will begin to say "no", and the Chair would urge you to give serious consideration to not attempting to introduce legislation, unless it is emergency, after this week. Thank you.
