The SPEAKER: The gentleman from Madison, Mr. Hendsbee, requests unanimous consent to introduce a Resolve notwithstanding the cloture order. The Clerk will read the title of the Resolve.

The CLERK: Resolve Authorizing Research of Cystic Fibrosis, a Disease of Children.

The SPEAKER: The Chair recognizes the same gentleman.

HENDSBEE: Mr. Speaker and Members of the House: Two weeks ago I spoke to you about this matter, and after considerable research we find that the State of Connecticut has appropriated the sum of twenty-five thousand dollars, the only state in the Union that we know of so far. We are not asking for nearly that amount of money, but we have arrived at the point where our Department of Health and Welfare will take this over and organize a clinic for research, administration of drugs, and with the hope that we may possibly find a cure for this dreaded of all killers of children, far more deadly than polio, something there is very little known about.

Now, I believe, Mr. Speaker and Members, that we will take considerable personal pride in having been a participant in something of this nature, because it deals solely with children, and small children at that. Many lives have been lost here throughout our State by not knowing the diagnosis of this terrible disease. To my mind, our participation in this will bring us up as being worthy of something, to my mind, the most worthwhile piece of legislation that has been presented to this or any other Legislature. I thank you.

The SPEAKER: Does the Chair hear objection to the reception of Resolve notwithstanding the cloture order?

The Chair hears none and the Re-

solve is received.

Thereupon, on motion of Mr. Hendsbee of Madison, the Resolve (H. P. 803) was referred to the Committee on Appropriations and Financial Affairs, ordered printed and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker and Members of the House: I feel in fairness to the Members of the House who are trying to observe a request made last week on introduction of bills after the cloture date. that a word of explanation is in order as to how your leadership feels on the subject. Following the announcement last week that we would try to make the cloture date have some meaning and effectiveness, a substantial small group of representatives approached your leadership and went on record as having bills that would be coming on the Floor of the House this week. The gentleman from Madison, Mr. Hendsbee, was one of those members.

Therefore, I want to impress upon the Members of the House that if some of the bills that may be introduced this morning and this week are not objected to, it is solely because they were put on record last week as having the bills being prepared. Thank you.

Mr. Elwell of Brooks was granted unanimous consent to address the

Mr. ELWELL: Mr. Speaker, Ladies and Gentlemen of the House: For the second time in the same week I find myself in a very embarrassing situation. I might explain at this point that this time it does not involve my car. Because I have such a great deal of respect for the rules which contribute to the efficiency as well as the dignity and decorum of the House, it is in all humility that I offer this Resolve notwithstanding the cloture rule.

The SPEAKER: The gentleman from Brooks, Mr. Elwell, requests unanimous consent to introduce a

Resolve notwithstanding the cloture order. The Clerk will read the title of the Resolve.

The CLERK: Resolve Providing for State Pension of Herbert Chase of Burnham.

The SPEAKER: Does the Chair hear objection to the introduction of Resolve notwithstanding the cloture order?

Whereupon, the Chair heard objection and the Resolve was not introduced.

On motion of the gentleman from Belfast, Mr. Rollins, the House voted to take from the table the sixth tabled and unassigned item, Bill "An Act relating to Certain Fees Payable to Insurance Commission-er", House Paper 201, Legislative Document 288, tabled on February 27 by that gentleman pending passage to be engrossed.

Thereupon, on further motion of the same gentleman, the Bill, having had its three several readings in the House and the Committee on Bills in the Third Reading having reported that no further verbal amendments were necessary, was passed to be engrossed and sent to the Senate.

Mr. LaCasce of Fryeburg was granted unanimous consent to address the House.

Mr. LaCASCE: Mr. Speaker, the Western Maine, West Oxford Registry discovered very recently that you had to have Legislative action in order to have one of the old books copied in order to make it official. That came in too late for me to get this in under the wire, and I request unanimous consent to enter a Bill which is not controversial.

The SPEAKER: The gentleman from Fryeburg, Mr. LaCasce, requests unanimous consent to introduce a Bill notwithstanding the cloture order. The Clerk will read the title of the Bill.

The CLERK: Bill "An Act Authorizing Copying of Volume Six, Oxford County, Western District, Registry of Deeds."

The SPEAKER: Does the Chair hear objection to the introduction of the Bill notwithstanding the cloture order?

The Chair recognizes the gentlewoman from Lovell, Mrs. Harriman. Mrs. HARRIMAN: Mr. Speaker, I would like to ask a point of rule. If we are going to accept any, let's accept all of them today and then put our thumbs down tomorrow.

The SPEAKER: Does the gentlewoman object to the introduction of the Bill?

The Chair recognizes the gentleman from Portland, Mr. Miller.

Whereupon, the Chair heard objection and the Resolve was not introduced.

Mrs. Harrington of Patten was granted unanimous consent to address the House.

Mrs. HARRINGTON: Mr. Speaker and Members of the House: I would like at this time to thank you all for remembering me while I was sick. I certainly appreciated it.

While I have the floor, I had a Bill last week that I was going to ask unanimous consent to present here today, but everybody scared me. I just talked with the gentleman from Bangor, Mr. Totman, about this Bill this morning, and he very graciously advised me to ask for unanimous consent to present this Act, and I am doing it.

The SPEAKER: The gentlewoman from Patten, Mrs. Harrington, requests unanimous consent to introduce a Bill notwithstanding the cloture order. The Clerk will read the title of the Bill.

The CLERK: Bill "An Act relating to Patten Water District."

The SPEAKER: Does the Chair hear objection to the introduction of the Bill notwithstanding the cloture order?

The Chair hears none and the Bill is admitted.

Thereupon, on motion of Mrs. Harrington of Patten, the Bill (H. P. 804) was referred to the Committee on Public Utilities, ordered printed and sent up for concurrence.

Mr. Call of Cumberland was granted unanimous consent to address the House.

Mr. CALL: Mr. Speaker and Members of the House: Notwithstanding the cloture rule, and the objections of the gentleman from Portland, Mr. Miller, and notwithstanding that the lady on my right here was sick last week and was unable to present her bill, and where

we demanded that this week that there would be no more bills accepted and we have had an objection from the floor, I wonder if the gentleman would be courteous enough now to withdraw his objection and allow the House to take the matter out of order again.

The SPEAKER: The Chair is advised that under parliamentary rules the objection cannot be withdrawn, and such an objection is not subject to reconsideration.

The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I rise on a point of inquiry. Would it be possible on the next legislative day, for the same bills which had been introduced and denied to be introduced on the next legislative day?

The SPEAKER: The Chair is advised that any member of the House may request unanimous consent to do anything.

Mr. Childs of Portland was then granted unanimous consent to address the House.

Mr. CHILDS: Mr. Speaker and Members of the House: Whereas the leadership of the House of both parties has determined that this is the final week of introducing bills notwithstanding the cloture rule, I feel that the Members of the House should abide by the thinking of both parties and, therefore, I shall hope that for the remainder of the week that the House will extend to the leaders of the House their adept right in their thinking, which is allowing members to introduce bills for the remainder of this week.

Mr. Fuller of South Portland was granted unanimous consent to address the House.

Mr. FULLER: Mr. Speaker and Ladies and Gentlemen of the House: I want to second what Mr. Childs has said. You know, if he or I were to introduce a bill by unanimous consent, I think you would be justified in objecting. We have been around here long enough so we should know better, unless it might possibly be an emergency.

On the other hand, some of these people, it is their first term in the Legislature, and I think we should give them every possible consideration and I think any objection should come from the leadership. Apparent-

ly, these people who are trying to introduce bills by unanimous consent have cleared these bills with the leadership, otherwise there would be objection. I would just like to say that if you have faith in your leadership, the objection should come from them. Thank you. (Applause)

The SPEAKER: The House is proceeding under Orders of the Day.

Mr. Crockett of Freeport was granted unanimous consent to address the House.

Mr. CROCKETT: Mr. Speaker and Members of the House: About a quarter of ten I received word that I would have a Bill ready tomorrow that pertains to health and welfare of the people of my town, that is namely a sewerage district. Now, if I am denied that privilege of presenting this Bill tomorrow that is being prepared now, it will put us back two years until the next Legislature sits, which will be the Ninety-ninth Legislature. I wouldn't present this Bill if it wasn't a matter of health and welfare, and I assure you that I do hope that you will allow me to present this Bill tomorrow when it is ready.

Mr. Dumais of Lewiston was granted unanimous consent to address the House.

Mr. DUMAIS: Mr. Speaker and Members of the House: I have a Resolve that was presented to me last Friday afternoon, which I would like to introduce.

The SPEAKER: The gentleman from Lewiston, Mr. Dumais, requests unanimous consent to introduce a Resolve notwithstanding the cloture order. The Clerk will read the title of the Resolve.

The CLERK: Resolve Designating E as t Deering Expressway as Charles J. Loring, Jr. Memorial Highway.

The SPEAKER: Does the Chair hear objection to the reception of the Resolve notwithstanding the cloture order?

The Chair hears none and the Resolve is admitted.

Thereupon, on motion of Mr. Dumais of Lewiston, the Resolve (H. P. 805) was referred to the Committee on Highways, ordered printed and sent up for concurrence.

Mr. Plante of Old Orchard Beach was granted unanimous consent to address the House.

Mr. PLANTE: Mr. Speaker and Members of the House: Whereas Lady Luck left Old Orchard Beach last Saturday at the hands of a pretty potent team, known as Pemetic High School from Southeast Harbor, I humbly congratulate both Pemetic High School and their Representative, Mr. Graves.

The SPEAKER: The House is proceeding under Orders of the Day.

On motion of the gentleman from Portland, Mr. Miller, the House voted to take from the table the fourth tabled and unassigned matter, Bill "An Act Increasing Debt Limit Under Small Claims Law", Senate Paper 102, Legislative Document 232, tabled on February 26 by that gentleman pending passage to be engrossed.

Thereupon, on further motion of the same gentleman, the Bill, having had its three several readings in the House and the Committee on Bills in the Third Reading having reported that no further verbal amendments were necessary, was passed to be engrossed and sent to the Senate.

Mr. Quinn of Bangor was granted unanimous consent to address the House.

Mr. QUINN: Mr. Speaker and Ladies and Gentlemen of the House: We have been elected by our constituents to come here in this general court and consider what legislation is good for our great State. We have had a Cloture Rule to expedite and make more efficient our work. I do not think, however, that if the occasion should arise while this court is in session, that the door should be closed tightly against legislation that may become necessary even after the date of the Cloture Rule. But I do think, the way the situation has developed here this morning, it would seem that the Members would feel that no matter what emergency might arise within our State or their communities, it is too late to be taken care of while we are in session here doing work for the State of Maine.

I would suggest that if there was such an emergency, that those that have the problem to dispose of should be in such a position where they might sit down with the leaders of the majority and minority parties and present their problem to them to see if it isn't a matter that shouldn't be given the consideration of this Legislature while it is in There may be something session. come up that would be quite important and possibly a first-termer here in the House might say "I can't do anything about it because they won't allow us to present a new bill.'

We are here about the State's business, and if there is a serious situation that arises that deserves the attention of the House I think it should be presented, but I think it should be cleared with our leaders in both the majority and minority parties. I thank you. (Applause)

Mr. Totman of Bangor was granted unanimous consent to address the House.

Mr. TOTMAN: Mr. Speaker

and Members of the House: I think it is in order for me to express my thanks to the gentleman from Bangor, Mr. Quinn, for emphasizing the point he just made.

I wish to assure the Members of the House that there is absolutely no reason while this Legislature is in session, if there is a matter of district importance or sufficient importance that you wish to introduce a bill right up to the closing day by unanimous consent, I am certain, and I think I can speak correctly for gentleman from Brunswick. from the other side of the aisle, Mr. Walsh, that if your leadership is consulted and is asked to cooperate. we will indeed assist you in every way possible. Thank you.

The SPEAKER: The House is proceeding under Orders of the Day, The Clerk will read a notice.

On motion of Mr. Crockett of Free-port,
