Thursday, March 7, 1957

The House met according to adjournment and was called to order by the Speaker.

Mr. EARLES: Mr. Speaker and Members of the House: In the event that there may be some desire for knowledge as to what this particular item refers to, the County Sheriff in Cumberland County, some time ago, a matter of a few days ago, mentioned the particular situation that apparently prevails there. A man convicted of, we will say in this instance, intoxication violations, they are given fines, and as a consequence of that for their inability to pay they may be jailed, but they may have signed notes that will indicate they will pay in the future. They have no assets, they have no ability to pay at all, but these obligations remain on the county books.

The County Auditor comes around and checks the books and finds that actually it is of no value at all because there is nothing to be recovered. So, it was on the recommendation of the Auditor and the Sheriff, and subsequently it was brought to the attention of the Senator from Cumberland, Mr. Davis, who as a result of that request, introduced the Bill.

The SPEAKER: Does the Chair hear objection to the reception of this Bill by unanimous consent notwithstanding the cloture rule?

The Chair hears none and the Bill is admitted.

The SPEAKER pro tem: The chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker and Members of the House: I think you are all well aware that in the event of airplane crashes and railroad accidents, particularly those involving fatalities, it is a very normal procedure for various groups to make an inquest inquiry to determine what steps can be taken to prevent a reoccurrence of the same type of accident, particularly at that site.

I have often wondered, since my first interest in highway safety, why it was that a highway fatality did not warrant the dignity and a lesson to be learned by a study of the various departments involved. It is with that interest in mind solely, that we may benefit from the price that people pay when they are killed, that I am asking that these two Committees study the advisability of legislation that would set up a Committee composed of a member of the Highway Department. а member of the State Police, a member of the Secretary of State's Office, and a member of the Governor's Highway Safety Committee.

I think we would be overlooking an opportunity to eradicate some of the very serious hazardous locations in the State if we did not benefit from highway fatalities and certainly do our human utmost to prevent a reoccurrence at the very same location, and therefore I urge passage of the Order. The motion prevailed, the Order received passage and was sent up for concurrence.

I was a little surprised at the time, just for an instant, because I had understood it was going to be put in another committee, and for that reason just to straighten myself out and get a little more information I had it tabled at that time. I don't want the Towns and Counties Committee to feel that it was any reflection on them certainly. I have decided that is the Committee in which I want the matter placed.

So, I now move that L. D. 1172, "An Act to Incorporate the Town of West Paris", shall be referred to the Committee on Towns and Counties.

The SPEAKER: The gentlewoman from Paris, Mrs. Mann, moves that L. D. 1172, Bill "An Act to Incorporate the Town of West Paris", be referred to the Committee on Towns and Counties. Is this the pleasure of the House?

The motion prevailed and the Bill was referred to the Committee on Towns and Counties and sent up for concurrence.

We have a problem whereby an eight-year-old is insane. It is not a question of being mentally deficient, there is a mental age of twelve years in the eight year old child, but there is a problem here, and there may be other problems in the State. This was not brought to our attention until after the cloture date. So, for that reason and with the explanation, - T would like at this time to present this Bill notwithstanding the cloture rule for unanimous consent by the body at this time.

The SPEAKER: The gentleman from Caribou, Mr. Brewer, requests unanimous consent to introduce a Bill notwithstanding the cloture order. The Clerk will read the title of the Bill.

The CLERK: Bill "An Act relating to Age of Admission to State Hospitals".

The SPEAKER: Is there objection to the reception of this Bill notwithstanding the cloture order?

The Chair hears none and the Bill is admitted.

Thereupon, on motion of the gentleman from Caribou, Mr. Brewer, the Bill (H. P. 85) was referred to the Committee on Public Health, ordered printed and sent up for concurrence.
