Amend said Bill by striking out the Title and inserting in place thereof the following Title: 'An Act Relating to Number of Councillors and Members of Superintending School Committee in Town of Fort Fairfield.'

Further amend said Bill by inserting at the beginning of the first line the underlined abbreviation and figure 'Sec. 1.'

Further amend said Bill, in the 5th and 6th lines of that part designated "Sec. 2", by striking out the underlined words "the Revised Statutes of 1954 and amendments thereto" and inserting in place thereof the underlined words 'section 2-A'

"Sec. 2. P. & S. L., 1943, c. 5, \$2-A, additional. Chapter 5 of the private and special laws of 1943, as amended, is hereby further amended by adding thereto a new section,

'Sec. 2-A. Superintending school committee; election; salary. The superintending school committee shall be composed of 5 in number and shall be elected as follows:

At the next annual town meeting to be held in March, 1958, 2 members shall be elected for a term of 3 years, 2 members for a term of 2 years and one member for a term of one year; and thereafter the annual vacancies caused by the expiration of terms shall be filled for terms of 3 years. Vacancies due to death, resignation or other causes shall be filled for the unexpired term at the next annual town meeting or at a special town meeting called for that purpose.'

Further amend said Bill by striking out the question in the Referendum and inserting in place thereof the following question: "Shall the Act Relating to Number of Councillors and Members of Superintending School Committee in Town of Fort Fairfield, passed by the 98th Legislature, be accepted?"

Amend said Bill by striking out all of the Emergency Preamble.

Further amend said Bill in "Sec. 3" by adding after "act," at the end of the 3rd line from the end, the following: "including \$70,000 principal amount of 2\%4 per cent water department bonds of said Bridgton Centre

Village Corporation, dated May 1, 1955,'

Further amend said Bill in "Sec. 10" by adding after "created," at the end of the 5th line, the following: 'and any indebtedness of said Bridgton Center Village Corporation assumed by said district pursuant to the provisions of this act,'

Further amend said Bill in "Sec. 11" by striking out the 2nd sentence and inserting in place thereof the following: 'Each of the present trustees of the water department of the Bridgton Centre Village Corporation shall continue as a trustee of said district, and shall hold office until the annual meeting of the inhabitants of the town of Bridgton held in the year in which his term of office as a trustee of Bridgton Centre Village Corporation would have expired and until his successor is duly elected or appointed.'

Further amend said Bill in "Sec. 13" by adding after the word "created" at the beginning of the 11th line thereof the words 'or assumed' and by adding after the word "created" in the 13th line the words 'or assumed'

Further amend said Bill by striking out the first 3 lines of the Emergency clause at the end of said Bill and inserting in place thereof the following:

'Referendum; effective date; certificates to Secretary of State. This act shall take effect 90 days after adjournment of the Legislature, only for the purpose of permitting its submission'

nicipal Water System for said Corporation."

Amend said Bill by striking out the period at the end of "Sec. 2" thereof and adding the following:

'; provided, however, nothing herein contained shall be construed as authorizing said Paris Village Corporation to take by right of eminent domain any of the property or facilities of any other public service corporation or district, used or acquired for future use by the owner thereof in the performance of a public duty, unless expressly authorized thereto herein or by subsequent act of legislature.'

Further amend said Bill by adding at the end of "Sec. 4" thereof the following new paragraph:

'In case of any crossing of any public utility, unless consent is given by the company owning or operating such public utility as to the place, manner and conditions of the crossing within 30 days after such consent is requested by said Paris Village Corporation, the Public Utilities Commission shall determine the place, manner and conditions of such crossing; and all work on the property of such public utility shall be done under the supervision and to the satisfaction of such public utility, but at the expense of the said Paris Village Corporation.
