#### Orders

Mr. Totman of Bangor presented the following Order and moved its passage:

WHEREAS, there occurred in Bucksport, Maine on October 19, 1956 a daytime bank robbery of \$12,000 by two out-of-state gunmen, and

WHEREAS, there occurred in Bangor, Maine on March 14, 1957 the shooting of a taxicab driver by a heavily armed, dangerous former inmate of an out-of-state mental institution—the same gunman who allegedly several days earlier held up and caused the death of an Auburn store proprietor, and

WHEREAS, on both of the aforementioned dates, arrests were made by members of the City of Bangor Police Force, assisted by State and County enforcement agencies as well as by individual citizens, in less than five hours following the time of each of the aforesaid instances, therefore BE IT ORDERED, the Senate concurring, that this Legislature commends the members of the City of Bangor Police Force, and those assisting them, for this outstanding record bringing great credit not only upon themselves but also upon the community which they so ably represent and protect;

BE IT FURTHER ORDERED, the Senate concurring, that an attested copy of this Joint Order be sent to the City Manager and Chief of Police of the City of Bangor. (H. P. 927)

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker and Members of the House: I believe the contents of this Order are reasonably self-explanatory. However, I feel a few additional comments may emphasize the merit of the particular Order.

On October 19, the crime committed in the Order in Bucksport occurred twenty miles from Bangor at 11:40 in the morning. Two hours and twenty minutes later, both criminals and the original twelve thousand dollar loot were recovered.

Last week, Thursday, March 14, a local citizen was kidnapped, terrorized and shot at 2:35 in the afternoon. Less than five hours later he was apprehended and behind bars.

This batting average is, I believe, a most justified source of pride. I urge passage of this Order not only for commendation publicly of the City of Bangor police force, but more important also, to serve notice that the State of Maine is not an easy mark for out-of-state criminals. Thank you.

The SPEAKER: Is it the pleasure of the House that this Order shall receive passage?

The Chair recognizes the gentleman from Bridgton, Mr. Haughn.

Mr. HAUGHN: Mr. Speaker, I am wholeheartedly in support of this House Order, but I question one thing in my mind. If these men are convicted and are found guilty of this crime as so charged, if we as legislators go along to find out if these men—in my thinking this bill would almost create the feeling they are guilty. I am certainly in wholehearted support of praising those police for capturing these men, but until they are found guilty I have a little question in my mind.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker, I think the point of the gentleman from Bridgton, Mr. Haughn, is well taken, and I appreciate his raising the question, but I can assure the gentleman that this point was taken up with legal minds who have felt that there would be absolutely no harm in commending a police force for capture.

The SPEAKER: The motion before the House is the motion of the gentleman from Bangor, Mr. Totman, that this Order receive passage. Is this the pleasure of the House?

Mr. CROCKETT: Mr. Speaker, I am generally up half a dozen times, but this time I was a little late.

I can't see that the minority signer Mr. Denbow, the gentleman from Lubec, is here, therefore my intentions—Oh, he is, I couldn't see him, I am sorry, I retract everything I said. I just wanted to protect Mr. Denbow, he being the minority signer of that Bill, I thought he was absent.

The SPEAKER: The Chair recognizes the gentleman from Lubec, Mr. Denbow.

Mr. DENBOW: Mr. Speaker and Members of the House: I would like to comment briefly on this Bill, and I did notice that the gentleman from South Berwick, Mr. Flynn, was to have this tabled so it doesn't matter too much.

However, my reason for signing this Report is quite deep. I feel sort of like the woman who said that everybody except her boy was out of step in the Army. I am in that position — I think that I am in step and the rest of the Committee are out.

This Bill was put in to compensate State Police in the amount of one hundred dollars each for eight members who are assigned to special investigation. They receive the same pay as other State Police, but the other State Police have their uniforms purchased. There is nothing in the law which permits the State Police Department to purchase plain clothes for these plain clothes men.

Consequently, they are being discriminated against by having to purchase their own which are torn off them quite a bit. And the other members of the Department are very much in favor of this money being spent. It involves eight hundred dollars. The purpose of the Bill was only to legalize the condition already existing. The Governor and the Council already appropriate this money, they take it out of a fund and pass it along to buy suits with. It was very well spoken for by Mr. Herron and other members of the Department, and it was opposed by one man.

Now, they came up with an answer like this, which to me is absolutely wrong. This will involve the expense of eight hundred dollars only, eight men. They are entitled to it because they are not getting the same consideration the other members are. Now the answer comes up that somebody says "We can take care of it in a different way. We can raise these eight men one step, one bracket," which amounts to roughly four dollars per week or two hundred dollars per year or sixteen hundred dollars instead of the eight originally requested. That is all very well, but when you do that you are automatically increasing the pay of these eight members one hundred dollars above the other remaining members of the force, so you reverse the position where you have perhaps two hundred members that are being discriminated against one hundred dollars the other way, they would automatically pick it up.

So in my opinion, and I think Colonel Marx bears me out on this, and I think the rest of the Committee will also bear me out, that the move is already on foot to ask the Personnel Department to increase them one step, which means the sixteen hundred dollars for these men instead of the eight hundred they requested. I am certainly not in favor of giving somebody double what they request. And it also reverses the position where taking for example if there were two hundred members of the force. I don't know how many there are, you could easily see that this reverses the position where it might mean two hundred dollars per person for the remaining two hundred people or amount to forty thousand dollars. You still have discrimination.

The acceptance of this Minority Report will iron it out. That is my belief and that is my reason for signing it.

We have located fifteen cases so far in the State of people who have children affected with this terrific disease and of those who have lost their children. I will assure you that this has become a little bit too big for any one person to handle, particularly a freshman representative.

I have spent a lot of time on it, I have contacted a lot of people. All the doctors are very much in favor of what we are doing, and I would like to convey to you that if in your district you have or know of people that have children affected with this disease, that you would get letters from their folks to testify to that fact. Telephone calls can be forgotten and they cannot be produced, a letter can.

We have contacted the Boston City Hospital and they are going to supply us with all the information they have, and I feel that we are going forward on something terrific, because the letters that I have received, it would be very difficult to read them dry-eyed. And for those of us who have had children and have children now, it is of the concern of each and every person here assembled, and I hope that you will so feel that you are being included in this measure. I thank you. (Applause)

Mrs. Knapp of Yarmouth was granted unanimous consent to address the House.

Mrs. KNAPP: I wish to introduce this Resolve notwithstanding the cloture rule.

Last Thursday evening at eleven p.m. an escapee from the Pownal State School stole a 1954 Chevrolet station wagon from the driveway of Elwood Gerry at North Yarmouth. He is asking reimbursement from the State for \$700. damage, that was an estimate by two different people. A note concerning this is on each desk. They are hard working, goodliving people and well deserving. If we do not go along with this it would certainly create a hardship on them, and I certainly hope that you do go along with this Resolve.
