Thursday, March 21, 1957

The House met according to adjournment and was called to order by the Speaker.

Mr. TOTMAN: Mr. Speaker, I present an amendment to the House Order and move its passage.

The SPEAKER: The gentleman from Bangor, Mr. Totman, presents an amendment to the House Order and moves its passage.

The Clerk will read the Amendment.

The Clerk read House Amendment "A" as follows: HOUSE AMENDMENT "A" to

House Order Relative to Use of Hall of House for Sessions of House Only.

Amend said Order by adding at the end thereof before the period the following words:

'during this regular session of the Legislature'

The SPEAKER: The Chair recognizes the same gentleman.

Mr. TOTMAN: Mr. Speaker and Members of the House: The purpose of this amendment is to satisfy the objections of those members who were somewhat concerned that we were attempting to pass an Order which would do more than intended, in other words, would carry over beyond the adjournment of this session. I believe you will see this amendment makes it very clear that that was not the intent.

Before having the amendment put to a vote. I would like to proceed to comment briefly on the Order in general. It was reported to us vesterday that some people felt it was most unfortunate that the Education Committee apparently, allegedwas blocked from using the lv House. I can assure you that I was one of the many in this House who thought that after the discussion yesterday they were going to use the House, and I was quite surprised when I discovered that they were down in Room 228. I took it upon myself to go down and check. I spoke to the Senate Chairman and the House Chairman and in view of the large audience, I offered to have them adjourn to use the House Chambers since I believe you as a group had indicated that you wished them to come up here. I wish to report that they declined the invitation, and furthermore, today the Senate Chairman asked me to convey to the House his appreciation for the House extending the use of the House Chamber yesterday, but they were generally satisfied with the conditions in Room 228.

I repeat the few comments I made yesterday about this Order. It is your House, it is your office space. I believe you should retain it for that purpose, and I further believe, for those of you who know of occasions when you feel you would like to see the House used for a hearing, if you feel strongly enough about it, I would recommend that we put in an individual order for that day. I believe, with that explanation, unless there are further questions, I would like to ask the adoption of this amendment.

The SPEAKER: The motion before the House is the motion of the gentleman from Bangor, Mr. Totman, that House Amendment "A" to this House Order should be adopted. Is it the pleasure of the House that this Amendment shall be adopted? The motion prevailed.

Thereupon, the House Order relative to Use of Hall of House for Sessions of House Only, as amended by House Amendment "A" was passed and sent up for concurrence.

On motion of the gentleman from Cumberland, Mr. Call, the House voted to take from the table the sixth tabled and unassigned matter, "An Act relating to Registration Fees on Certain Commerical Vehicles", Senate Paper 25, Legislative Document 16, tabled on March 12 by that gentleman pending passage to be enacted.

ing passage to be enacted. The SPEAKER: The Chair recognizes the gentleman from Cumberland, Mr. Call.

Mr. CALL: Mr. Speaker and Members of the House: I now present House Amendment "A" to L. D. 16 and move its passage.

The SPEAKER: The Chair understands the gentleman from Cumberland, Mr. Call, now moves that the House reconsider its action whereby it passed to be engrossed, under suspension of the rules, "An Act relating to Registration Fees on Certain Commercial Vehicles", Senate Paper 25, Legislative Document 16. Is it now the pleasure of the House that we reconsider our action whereby this item was passed to be engrossed?

The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: I believe the Order is in order for debate, the motion to reconsider?

The SPEAKER: It is debatable, yes.

Mr. TOTMAN: Mr. Speaker, I would like to point out to the House and to the gentleman from Cumberland, Mr. Call, that inasmuch as this is a companion bill to another tabled and assigned matter, which I understand is going to be taken off the table next week, I would like to move that this item be retabled, specifically assigned to Thursday next, in order that it may be considered in connection with the major bill.

The SPEAKER: The Chair would advise the gentleman from Cumberland, Mr. Call, that the only debatable point at this time is the date of assignment specified by the gentleman from Bangor, Mr. Totman. The motion to table takes precedence and is not debatable.

The motion before the House is the motion of the gentleman from Bangor, Mr. Totman, that Item 6 be retabled and specially assigned for Thursday of next week. Is this the pleasure of the House?

All those in favor will please say aye; those opposed, no.

A viva voce vote being taken, the motion prevailed and the Bill was retabled pending passage to be enacted, and specially assigned for Thursday, March 28.

The following paper from the Senate was taken up out of order by unanimous consent.

From the Senate: The following Order: (S. P. 495)

ORDERED, the House concurring, that the following bill be recalled from the Governor to the Senate:

Bill, "An Act relating to Investment of Municipal Trust Funds" (H. P. 342) (L. D. 473)

Came from the Senate read and passed.

In the House, was read and passed in concurrence. On motion of Mr. Totman of Bangor, by unanimous consent, was ordered sent forthwith to the Senate.

Mrs. Hatch of Minot was granted unanimous consent to address the House.

Mrs. HATCH: Mr. Speaker and Members of the House: Last Monday of this week the residents of Mechanic Falls held their annual town meeting, and at this time they decided that they wanted to hold their town meetings in the future on the third Saturday of March instead of the third Monday of March as is now stated in the Act which gave Mechanic Falls its manager form of government. As this change requires an act of legislature I ask unanimous consent to present this Bill notwithstanding the cloture order.

The SPEAKER: The Clerk will read the title of the Bill.

The CLERK: Bill "An Act relating to Time of Annual Town Meeting in Town of Mechanic Falls."

The SPEAKER: Is there objection to the introduction of this Bill notwithstanding the cloture order?

The Chair hears none and the Bill is introduced.

Thereupon, on motion of Mrs. Hatch of Minot, the Bill, (H. P. 988) was referred to the Committee on Legal Affairs, ordered printed, and sent up for concurrence.

The SPEAKER: The House is proceeding under Orders of the Day.

On motion of Mr. Tevanian of Portland, the House voted to reconsider its action of March 20 whereby Bill "An Act Relating to Retirement Benefits for Members of City of Portland Police and Fire Departments", Senate Paper 179, Legislative Document 458, was passed to be engrossed.

On further motion of the same gentleman the Bill was tabled pending passage to be engrossed, and specially assigned for Wednesday, March 27.

On motion of the gentleman from Portland, Mr. Tevanian, the House voted to take from the table the fifth tabled and unassigned matter, Bill "An Act relating to Persons to Whom Liquor Licenses May Not be Issued", Senate Paper 262, Legislative Document 701, tabled on March 12 by that gentleman pending third reading.

Thereupon, Mr. Tevanian of Portland offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to S. P. 262, L. D. 701, Bill, "An Act Relating to Persons to Whom Liquor Licenses May Not Be Issued."

Amend said bill by striking out in the last line thereof the underlined figure and word "5 years" and inserting in place thereof the underlined figure and word '1 year'.

On motion of Mrs. Christie of Presque Isle, the Bill was tabled pending adoption of House Amendment "A" and specially assigned for the next legislative day.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker and Members of the House: In order that the Republican members of the House may better plan their schedule next week there will be an evening caucus of the Republican Party on Tuesday. The time will be announced.

The gentleman from South Portland, Mr. Fuller, was granted unanimous consent to address the House.

Mr. FULLER: Mr. Speaker and Members of the House: I would like to bring to the attention of the gentleman from Bangor, Mr. Totman, that there is a very important meeting next Tuesday night of the Education Committee, the Research Committee and probably members of the Appropriations Committee, to study the Committee meeting on the Jacobs Report, and it might be a good idea to have the caucus on some other evening. Thank you very much. The gentleman from Freeport, Mr. Crockett, was granted unanimous consent to address the House.

Mr. CROCKETT: Mr. Speaker and Members of the House: I also wouldn't miss this caucus if it was possible, but I will be away Tuesday on business and I would like to have it some other day.

The gentleman from Bangor, Mr. Totman, was granted unanimous consent to address the House.

Mr. TOTMAN: Mr. Speaker and Members of the House: Of course I was quite disturbed to hear that I had suggested something for the members of the Republican Party on Tuesday night conflicting with Education. But when I heard that the gentleman from Freeport, Mr. Crockett, couldn't be there, well, that just settled it, so I am afraid we will have to postpone it.

The SPEAKER: The House is proceeding under Orders of the Day.
