The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Claude D. Nutter of the Baptist Church, Charleston.

The SPEAKER: The Chair recognizes the gentleman from Gouldsboro, Mr. Tarbox.

Mr. TARBOX: Mr. Speaker and Members of the House: I would like to say something on this resolve, L. D. 746, declaring the Chinook the official dog of Maine.

I heard this hearing and Senator Dow really gave one of the best explanations of why he presented this bill, and why he thought it would help to advertise the State of Maine by making the Chinook dog the State dog.

On your desks there is a statement from Bernice Richmond of Winter Harbor with fifteen reasons why she thinks the Chinook dog should be the State dog. I am not going to read this statement. The Chinook has been featured by nine national magazines, including the Saturday Evening Post, True, Outdoor Life and many others. Every year thousands of out-of-state visitors stop at the Chinook kennels and eleven thousand signed the guest book last year by actual count. This has been going on for years. People from as far away as Seattle, Arizona, Colorado and other states across the country have written saying it was the Chinook that first brought them to Maine, and now they look forward to returning to our beautiful State.

Nowhere else in the world can you get a purebred Chinook dog but in the State of Maine, as this is the only state where they are raised. You can't get one of these dogs unless you come here after it, as the owner will not ship one by freight or express. I assume the Committee feels that Maine doesn't need a State dog, but we have voted for Poetry Day and we have a chickadee for a State bird, a pine tree for a State tree, and I can't see why we shouldn't have a State dog. So I move that the resolve be substituted for the report.

The SPEAKER: The motion before the House is the motion of the gentleman from Gouldsboro, Mr. Tarbox, that with respect to Resolve Declaring the Chinook the Official Dog of Maine the Resolve be substituted for the Report.

The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker and Members of the House: I very frankly as House Chairman of the Committee on State Government have no particular reason to try to dissuade you as Members of the House if you want a State dog, why the Chinook should not be the State dog. But quite frankly and honestly and simply, the Committee did not feel that the State of Maine is ready yet to adopt a State dog. If you want one, I think we are perfectly willing to let the Members of the House decide that issue.

The SPEAKER: The Chair recognizes the gentleman from Portland,

Mr. Childs.

Mr. CHILDS: Mr. Speaker, I move the bill and its accompanying papers be indefinitely postponed.

The SPEAKER: The motion now before the House is the motion of the gentleman from Portland, Mr. Childs, that this Resolve and all accompanying papers be indefinitely postponed.

Will all those who favor the motion of the gentleman from Portland, Mr. Childs, that this Resolve and accompanying papers be indefinitely postponed, please say aye,

those opposed, no.

A viva voce vote being taken, the motion prevailed and the Resolve and all accompanying papers were indefinitely postponed and sent up for concurrence.

The SPEAKER: With respect to Item one, Bill "An Act relating to Appointment of Institutional Heads in Department of Institutional Services", Senate Paper 186, Legislative Document 465, the gentleman from Bridgton, Mr. Haughn, moves that it be retabled unassigned, pending acceptance of the Committee Report in concurrence. Is this the pleasure of the House?

The motion prevailed, and the Bill was tabled pending acceptance in concurrence and unassigned.

The SPEAKER: The Chair now lays before the House the second tabled and today assigned matter Bill "An Act Creating an Advisory Committee on Poultry within Department of Agriculture", tabled on April 2 by the gentleman from Brooks, Mr. Elwell, pending reference to any committee, and the Chair recognizes that gentleman.

Mr. ELWELL: Mr. Speaker and Members of the House: With all due respect to the Committee on Reference of Bills, there is much in this bill of a technical nature that does not appear on the surface which applies to the Department of Agriculture. While there is a small appropriation involved, I would move that the bill be referred to the Committee on Agriculture.

The SPEAKER: The gentleman from Brooks, Mr. Elwell, with respect to the Bill "An Act Creating an Advisory Committee on Poultry within Department of Agriculture", House Paper 1022, Legislative Document 1466, now moves that this Bill be referred to the Committee on Agriculture. Is this the pleasure of the House?

The motion prevailed and the Bill was referred to the Committee on Agriculture.

The SPEAKER: Under Orders of the Day the Chair now lays before the House the third tabled and today assigned matter, Resolve Directing Boxing Commission to Change Decision on Rocky Marciano Case, House Paper 765, Legislative Document 1047, tabled on April 2 by the gentleman from Bangor, Mr. Quinn, pending second reading, and the Chair recognizes that gentleman

Mr. QUINN: Mr. Speaker, Ladies and Gentlemen of the House: This was tabled in order that the title of the act might be amended to conform with the changes in the body of the act. In other words, take out the word "Directing" a government agency to take certain action and authorizing them to do so at their discretion.

I believe there is a filing on this amendment which, I don't know the number of it, but it will take care of the change in the title. I now move that it be amended accordingly.

The SPEAKER: The gentleman from Bangor, Mr. Quinn, now offers House Amendment "A" to Legislative Document 1047, and moves its adoption. The Clerk will read the amendment.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 765, L. D. 1047, Resolve

Directing Boxing Commission to Change Decision on Rocky Marciano Case.

Amend said Resolve by striking out in the Title, the word "Directing" and inserting in place thereof, the word 'Authorizing'.

House Amendment "A" was adopted, the resolve given its second reading, and having been reported by the Committee on Bills in the Third Reading was passed to be engrossed and sent to the Senate.

The SPEAKER: Under Orders of of the Day the Chair now lays before the House the fourth tabled and today assigned matter, Bill "An Act relating to Taxation Exemption of Certain Property of Veterans", House Paper 97, Legislative Document 127, tabled on April 2 by the gentleman from Cape Elizabeth, Mr. Beyer, pending third reading, and the Chair recognizes that gentleman.

Mr. BEYER: Mr. Speaker, Ladies and Gentlemen of the House: Before moving for the third reading of this bill I would like to just speak briefly on it. When I first put it in, some of you may remember, it was to cover conveyances between husband and wife and only from wife to husband. The bill in its present form is considerably broader and I am slightly concerned upon the tax impact to towns. However, I am going to move its passage.

This of course, as you know, involves the veterans bill whereby property up to \$3,500 valuation is exempt from taxation for veterans over sixty-two or those one hundred per cent disabled. As the amendment now goes, any conveyance between husband and wife is now permissible at any time whether she inherited the property or what. So, although it is a little broader than I originally planned the bill, subject to amendments by various interested people, I now move for third reading.

Thereupon, on motion of Mr. Beyer of Cape Elizabeth, the Bill was given its third reading, passed to be engrossed as amended and sent to the Senate.

The SPEAKER: The House is proceeding under Orders of the Day.

The SPEAKER: The Chair recognizes the gentleman from Gouldsboro, Mr. Tarbox.

Mr. TARBOX: Mr. Speaker, I would like to ask if the House is still in possession of House Paper 947, Legislative Document 1340?

The SPEAKER: The Chair is advised that the House is in possession of that document.

Mr. TARBOX: Now, I would like to move that we reconsider our action whereby yesterday we accepted the Report of the Committee.

The SPEAKER: The gentleman from Gouldsboro, Mr. Tarbox, with respect to Bill "An Act relating to Disposition of Commissions on Pari Mutuel Pools", moves that the House reconsider its action whereby it accepted the "Ought not to pass" Committee Report. Is there objection?

The motion prevailed.

Thereupon, on further motion of the gentleman the Bill was tabled pending acceptance of the Committee Report and unassigned.

On motion of the gentleman from Cumberland, Mr. Call, the House voted to take from the table the fourteenth tabled and unassigned matter, House Divided Report, Majority Report "Ought not to pass" and Minority Report "Ought to pass", of the Committee on Liquor Control on Bill "An Act relating to Obstructions in Windows of Liquor Licensed Premises". House Paper 430, Legislative Document 606. tabled on March 26 by the gentleman from Cumberland, Mr. Call, pending motion of the gentlewoman from Kittery, Mrs. Burnham, to accept Minority Report.

The SPEAKER: The Chair recognizes the gentleman from Lee, Mr. Frazier.

Mr. FRAZIER: Mr. Speaker, as sponsor of this bill, and in my absence last week it was tabled by the gentleman from Cumberland, Mr. Call, and I want to thank him for doing that. The bill, as I introduced it, was a simple thing. The object of it was only to have removed from disruptable conveyors of food and liquor, obstructions in

the window which prevent a person on the street from looking in before

they go in.

There are in my area of the State certain dispensers of food who build a nice front and inside it is not so very nice. There are some ladies and some gentlemen who, not recognizing what may be inside the building, do go in, and then are embarrassed to have to return.

I am aware of the fact that the Liquor Commission has a ruling similar to this on their books at the present time. However, it is not enforced in some areas of the State. I don't think it would do any harm for this to pass. I have no objection to the sale of liquor in restaurants if they are conducted properly. And, I am doing this so that a civil officer could take the necessary measures to have the obstructions in the windows removed, and I do hope the motion of the gentlewoman from Kittery, Mrs. Burnham. prevails.

The SPEAKER: The question before the House is the motion of the gentlewoman from Kittery, Mrs. Burnham, that the Minority "Ought to pass" Report be accepted.

The Chair recognizes the gentleman from Freeport, Mr. Crockett.

Mr. CROCKETT: Mr. Speaker, I served on this Committee. We took this thing under consideration and have found that there are rulings in the Liquor Commission's rulings today that cover this very same bill. So, therefore, I move indefinite postponement.

The SPEAKER: The motion now before the House is the motion of the gentleman from Freeport, Mr. Crockett, that Bill "An Act relating to Obstructions in Windows of Liquor Licensed Premises" and all accompanying reports and papers be indefinitely postponed. Is this the pleasure of the House?

The Chair recognizes the gentleman from Madison, Mr. Hendsbee.

Mr. HENDSBEE: Mr. Speaker, in my opinion, from what I have read and understood about this bill, I would like to go along with my colleague and seat mate here, the gentleman from Lee, Mr. Frazier. His bill was simply to clarify a matter which he feels is not being handled under a bill already existing, and if he has something better to add to

a circumstance of this kind, I am perfectly willing to go along with him and I believe, as Mr. Frazier has stated, that the motion of the gentlewoman from Kittery, Mrs. Burnham, should be accepted.

The SPEAKER: The Chair will restate the motion. The motion is for indefinite postponement of the bill, the reports and all accompanying papers. Is this the pleasure of the House?

Will those in favor please say aye; those opposed, no.

A viva voce vote being taken, the Chair declared the motion prevailed.

The SPEAKER: The ruling of the Chair has been doubted and the Chair will order a division.

Will those who favor the indefinite postponement of this bill please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Twenty having voted in the affirmative and eighty-eight having voted in the negative, the motion did not prevail.

The SPEAKER: The motion now before the House is the motion of the gentlewoman from Kittery, Mrs. Burnham, that the Minority "Ought to pass" Report on Bill "An Act relating to Obstructions in Windows of Licensed Premises," House Paper 430, Legislative Document 606, be accepted. Is this the pleasure of the House?

The motion prevailed and the Bill was given its first and second readings and assigned for third reading tomorrow.

The SPEAKER: The House is proceeding under Orders of the Day.

On motion of the gentleman from Rockland, Mr. Stilphen, the House voted to take from the table the fifth tabled and unassigned matter, Bill "An Act relating to Certain Highways in the State Primary System and Providing Funds Therefor", House Paper 864, Legislative Document 1238, tabled on March 13 by that gentleman pending reference to a Committee.

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Stilphen.

Mr. STILPHEN: Mr. Speaker and Ladies and Gentlemen of the House: This bill has been on the table for quite some time pending reference to a committee. The Committee on Reference of Bills, inasmuch as this had a tax measure attached to it, had thought possibly it should go to Taxation. After considering and talking with members of the Taxation Committee and after considering other angles, I now move it be referred to the Committee on Highways.

The SPEAKER: The gentleman from Rockland, Mr. Stilphen, moves

that Bill "An Act relating to Certain Highways in the State Primary System and Providing Funds Therefor." House Paper 864, Legislative Document 1238, be referred to the Committee on Highways. Is this the pleasure of the House?

The motion prevailed.

The SPEAKER: The House is proceeding under Orders of the Day.
