Wednesday, April 17, 1957

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Fabian Onderovsky of the Sts. Cyril and Methodius Church of Lisbon Falls.

The SPEAKER: The Chair recognizes the gentleman from Stonington, Mr. Shepard.

Mr. SHEPARD: Mr. Speaker, is it permissible to ask for a brief breakdown of the reasons why this came out with an "Ought not to pass" Report? I am not going to make a motion, and I am not against the Committee Report. I would just like to have an explanation.

The SPEAKER: The gentleman from Stonington, Mr. Shepard, through the Chair asks of any member of the Judiciary Committee an explanation of the reasons for the "Ought not to pass" Report. Any member of that Committee may answer if he so chooses.

The Chair recognizes the gentleman from Portland, Mr. Broderick.

Mr. BRODERICK: Mr. Speaker, on item six, by way of explanation very briefly, by Statute you are prohibited from taking the corporate records without the State. If we were to pass this bill it would call for a complete revision of our corporate laws as they now exist. They cannot be taken without the State.

The SPEAKER: Is it now the pleasure of the House to accept the "Ought not to pass" Report of the Committee in concurrence?

Mr. TOTMAN: Mr. Speaker. prior to second reading of the bill, I wonder if I could address a question through the Chair to any member of the Public Health Committee to help those of us who are not able to follow these bills perhaps as close as we would like. Many of us have had letters regarding a very controversial nurses' bill, and I would like to inquire through the Chair if this is or is not the controversial bill which was heard I believe just last week?

The SPEAKER: The gentleman from Bangor, Mr. Totman, addresses a question through the Chair to any member of the Public Health Committee who may care to answer.

The Chair recognizes the gentleman from Limerick, Mr. Rowe.

Mr. ROWE: Mr. Speaker, this is not the controversial bill that was heard last week. This bill only increases their dues and fees for examination, it is their own bill.

The Bill was given its second reading and tomorrow assigned.

Mr. TEVANIAN: Mr. Speaker and Members of the House: Since April 10 when this measure was tabled by myself I have pretty well investigated it and I am as confused as before I started, but I feel that the equities definitely are in favor of Mrs. Fowler and Mr. Peterson, and therefore I arise in support of the motion of the gentleman from South Portland, Mr. Jones.

The SPEAKER: The motion before the House is the motion of the gentleman from South Portland, Mr. Jones, that the House accept the Majority "Ought to pass" Report.

The Chair recognizes the gentleman from Portland, Mr. Miller.

Mr. HAUGHN: Mr. Speaker and Members of the House: I have discussed this matter with the House Chairman of the Agriculture Committee, and we will need a little further time to take this Bill up with the Fish and Game Department, so I move at this time that it be tabled unassigned, and I will surely take it off when we arrange that meeting with the Department.

The SPEAKER: With respect to item number four, Bill "An Act relating to Killing of Dogs Chasing Livestock or Poultry", House Paper 990, Legislative Document 1419, the g e n t l e m a n from Bridgton, Mr. Haughn, moves that this item now be retabled unassigned pending acceptance of the Committee Report. The SPEAKER: Under Orders of the Day the Chair now lays before the House the fifth tabled and today assigned matter, Bill "An Act relating to Excise Taxes on Motor Vehicles of Those Who Reside on Veterans Administration Facility, Togus", House Paper 925, Legislative Document 1314, tabled on April 11 by the gentleman from Milo, Mr. Brockway, pending passage to be engrossed.

The Chair recognizes the gentleman from Chelsea, Mr. Allen.

Mr. ALLEN: Mr. Speaker and Members of the House: I wish to thank the gentleman from Milo, Mr. Brockway, for tabling this and giving me an opportunity to make an amendment which removes a lot of objection. So I offer House Amendment "A" to this Bill and move its adoption.

The SPEAKER: The gentleman from Chelsea, Mr. Allen, offers House Amendment "A" and moves its adoption.

The Clerk will read the amendment.

House Amendment "A" was read by the Clerk as follows: HOUSE AMENDMENT "A" to H. P. 925, L. D. 1314, Bill "An Act Relating to Excise Taxes on Motor Vehicles of Those Who Reside on Veterans Administration Facility, Togus."

Amend said Bill by striking out the underlined word "**persons**" in the second line of the underlined matter and substituting in place thereof the underlined words 'civilian officials and employees'.

The SPEAKER: Is it the pleasure of the House that House Amendment "A" shall be adopted?

The Chair recognizes the gentleman from Augusta, Mr. Carey.

Mr. CAREY: Mr. Speaker and Members of the House: I would like to say just a word in regard to this Bill and Amendment. There are approximately fifty-four civilian officials and employees who reside on the V. A. facility. I do not know how many own cars and I do not know where they individually pay their excise taxes. I do know that some pay in Chelsea, Augusta, Gardiner, Whitefield and Portland. There are likely other places.

So far as the instance of Augusta is concerned, I might say that the public school pupils from the V. A. attend school in Augusta, but Augusta does not feel that they should be required by law to pay their excise taxes in Augusta or elsewhere.

However, this is not an issue of Augusta versus Chelsea. I feel that it is an issue of individual rights versus the denial of rights. Some of these people do not vote presently due to the lack of voting residence. There is a bill in the mill now to give them the voting privilege. If they are granted this privilege they should vote wherever they choose. They also should pay their excise taxes wherever they choose. I hope that this body endorses the original Committee "Ought not to pass" Report.

The SPEAKER: The motion before the House is the motion of the gentleman from Chelsea, Mr. Allen, that House Amendment "A" be adopted, and the Chair recognizes that same gentleman.

Mr. ALLEN: Mr. Speaker and Members of the House: I would just like to say that I have talked to the Chairman and other members of the Taxation Committee, who now have told me with this amendment and with further information that they have been able to receive, that they now would not object to this Bill, so this is not entirely opposed by the Taxation Committee now.

The SPEAKER: The motion before the House is the motion of the gentleman from Chelsea, Mr. Allen, that House Amendment "A" be adopted. Is this the pleasure of the House?

The motion prevailed and House Amendment "A" was adopted.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Carey.

Mr. CAREY: Mr. Speaker, I feel it quite unfair for the Committee Report under any conditions to be anticipated. I move that this Bill as amended be referred again to the Committee.

The SPEAKER: With respect to item number five, Bill "An Act relating to Excise Taxes on Motor Vehicles of Those Who Reside on Veterans Administration Facility, Togus", House Paper 925, Legislative Document 1314, the motion now before the House is the motion of the gentleman from Augusta, Mr. Carey, that this Bill be referred back to the Committee on Taxation.

The Chair recognizes the gentleman from Chelsea, Mr. Allen.

Mr. ALLEN: Mr. Speaker, while this little bill really doesn't warrant the time it is getting, I feel so strongly that I am right, that here is something that belongs to the little Town of Chelsea, which I represent, that I must take up your time to defend it. I ask that we have a division when that vote is taken.

The SPEAKER: The motion before the House is the motion of the gentleman from Augusta, Mr. Carey, that this Bill be referred back to the Committee on Taxation. The gentleman from Chelsea, Mr. Allen, has requested a division.

The Chair recognizes the gentleman from Bangor, Mr. Totman.

Mr. TOTMAN: Mr. Speaker and Members of the House: On this question of referring the Bill back to Committee, I think it is entirely in order as a matter of general procedure, regardless of the merits of this particular Bill, for a Member of this House to offer an amendment

which he states in good faith that he has cleared with the Committee. And I certainly shall oppose any motion to refer it to Committee with the explanation that has been offered.

The SPEAKER: Is the House ready for the question?

The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, through the Chair I would like to inquire from any member of the Taxation Committee if there would be objection on their part to hear this matter again.

The SPEAKER: The gentleman from Portland, Mr. Childs, addresses a question through the Chair to any member of the Taxation Committee. Any member of that Committee may answer if he so chooses.

The Chair recognizes the gentleman from Wiscasset, Mr. Farmer.

Mr. FARMER: Mr. Speaker, I think perhaps it would be a good idea if it was referred back to the Committee. This is the first time I have heard anything of the amendment of the gentleman from Chelsea, Mr. Allen. That is just my own personal views, I don't know about the rest of the Committee.

The SPEAKER: The Chair recognizes the gentleman from Enfield, Mr. Dudley.

Mr. DUDLEY: Mr. Speaker, I would just like to remind the House that the gentleman from Brunswick, Mr. Walsh, isn't here today, and he was quite interested in this Bill.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Cyr.

Mr. CYR: Mr. Speaker, as a Member of the Taxation Committee, I would like to have that Bill back in Committee for review and reconsideration.

The SPEAKER: Is the House ready for the question?

The motion before the House is the motion of the gentleman from Augusta, Mr. Carey, that the Bill "An Act relating to Excise Taxes on Motor Vehicles of Those Who Reside on Veterans Administration Facility, Togus", House Paper 925, Legislative Document 1314, be recommitted to the Committee on Taxation. The gentleman from Chelsea, Mr. Allen, has requested a division.

Will all those who favor recommitting this Bill to the Committee on Taxation please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Ninety-two having voted in the affirmative and thirty-one having voted in the negative the motion prevailed and the Bill with accompanying papers was recommitted to the Committee on Taxation and sent up for concurrence.

The SPEAKER: Under Orders of the Day the Chair now lays before the House the sixth tabled and today assigned matter, Bill "An Act relating to Bank Deposits or Loan and Building Shares in Two or More Names", House Paper 918, Legislative Document 1308, tabled on April 11 by the gentleman from Bangor, Mr. Quinn, pending third reading, and the Chair recognizes that gentleman.

Mr. QUINN: Mr. Speaker and Ladies and Gentlemen of the House: I haven't been able to acquire all the information that I desired on this. I would ask that it be retabled until a week from today, April 24.

The SPEAKER: With respect to item number six, Bill "An Act relating to Bank Deposits or Loan and Building Shares in Two or More Names", House Paper 918, Legislative Document 1308, the gentleman from Bangor, Mr. Quinn, now moves that this item be retabled and specially assigned for one week from today, April 24, pending third reading. Is this the pleasure of the House?

The motion prevailed and the Bill was retabled pending third reading and specially assigned for April 24.

The SPEAKER: The Chair now lays before the House the seventh tabled and today assigned matter, House Report "Ought to pass in New Draft", House Paper 1048, Legislative Document 1490, of the Committee on Public Health on Bill "An Act relating to Age of Admission to State Hospitals", House Paper 850, Legislative Document 1203, tabled on April 12 by the gentleman from Portland, Mr. Childs, pending acceptance of report.

Thereupon the Committee Report was accepted, the New Draft given its first and second readings and tomorrow assigned.

The SPEAKER: At this time the Chair would like to recognize with a great deal of pleasure the presence in the rear of the Hall of the House of a group of ladies of the Hancock County Women's Republican Club, accompanied by Mrs. Perry Sargent and Mrs. Georgiana Sadler. On behalf of the House the Chair extends to you ladies a most cordial and hearty welcome, and we hope you will enjoy your visit with us today. (Applause)

The gentleman from Bangor, Mr. Totman, was granted unanimous consent to address the House.

Mr. TOTMAN: Mr. Speaker and Members of the House: I am somewhat reluctant to arise and request your support after I was just a few moments ago rather embarrassed by finding out that I had been given the wrong steer by a committee sentiment. However, I will take my chances on this one.

I understand that we have in possession of the House at this time a resolve or a memorial to Congress which is about to be referred to this branch, and I would recommend that since it is by unanimous consent that it would have to be admitted, that if you can see your way clear in your own individual conscience, allow this memorial to be introduced with the distinct understanding that it would be my recommendation that it would be tabled and specially assigned for the next legislative day rather than trying to ask this House to take action upon it today without a chance to study it. I will repeat, it will come in by unanimous consent, I would urge that you receive it and it will then be tabled by myself until tomorrow specially.

The SPEAKER: Is there objection to taking up under suspension of the rules and out of order, a paper from the Senate?

The Chair hears none. The Clerk will read the paper from the Senate. The paper from the Senate was read by the Clerk as follows:

To the President of the United States and to the Honorable Senate and House of Representatives of the United States of America in Congress Assembled.

Joint Resolution Memorializing the President and the Congress to Correct Governmental Policies which Create Unreasonable Competitive Disadvantages for the Cotton Textile Industry.

We, your Memorialists, the Senate and House of Representatives of the State of Maine in the 98th Legislative Session assembled, most respectfully present and petition The President and the Congress as follows:

WHEREAS, the Bates Manufacturing Company has announced the closing of two of its Maine plants, creating unemployment for thousands of Maine textile workers; and

WHEREAS, continued unfair foreign competition threatens the existence of the textile industry in Maine and other parts of the nation; and

WHEREAS, this threat is immediate, burdensome, and demoralizing to workers, their families and their neighbors; and

WHEREAS, these thousands of American citizens are confronted with unemployment, family displacement, and economic insecurity in a period of record high spending, high cost of living, and general prosperity; and

WHEREAS, federal policies have contributed to the crisis in the textile industry; and

WHEREAS, only the President and the Congress of the United States have the power to mobilize the resources of the federal government to alleviate this problem.

NOW, BE IT RESOLVED that we, the Members of the Senate and House of Representatives of the Maine State Legislature, do urgently request the President of the United States, Dwight David Eisenhower, to use the powers of his office and of the several departments of the government of the United States to effect immediate action to remedy the present situation in the textile industry and to establish a long-range program to provide for a healthy recovery and growth of the textile industry; and be it further

RESOLVED: That S. P. 314, "To assist the United States cotton textile industry in regaining its equitable share of the world market," and other measures designed to resolve the immediate emergency confronting the cotton textile industry and to promote its long-range prosperity, be acted upon forthwith by the Congress; and be it further

RESOLVED: That a copy of this Memorial, duly authenticated by the Secretary of State, be immediately transmitted by the Secretary of State to the President and to the Senate and House of Representatives in Congress, the membership of said Senate and House of Representatives from this State and to the presiding officers of each of the Legislatures in the New England States.

Read and adopted in the Senate.

The SPEAKER: The Chair understands now that the gentleman from Bangor, Mr. Totman, moves that this Memorial be tabled and specially assigned for tomorrow, and that it be reproduced and distributed to the desks of the members prior to tomorrow's session. Is this the pleasure of the House?

The motion prevailed and the Memorial was tabled pending reference and tomorrow assigned.

The SPEAKER: The House is proceeding under Orders of the Day.

On motion of the gentleman from South Portland, Mr. Fuller, the House voted to take from the table the forty-sixth tabled and unassigned matter, Bill "An Act relating to Educational Aid and Reorganization of School Administrative Units", Senate Paper 515, Legislative Document 1478, tabled on April 12 by that gentleman pending assignment for third reading.

The SPEAKER: The Chair recognizes the same gentleman.

Mr. FULLER: Mr. Speaker and Members of the House: Your Education Committee had an executive session this morning. We discussed some of the fine suggestions that we have had from citizens and from Members of the House, and we have another session scheduled.

We feel that you Members should have at least one more week end to talk with your constituents so that there won't be anything jammed down your throats in any way, shape or manner. And so, Mr. Speaker, I move that this Bill be assigned for third reading on Wednesday, April 24.

The SPEAKER: With respect to item forty-six, Bill "An Act relating to Educational Aid and Reorganization of School Administrative Units", Senate Paper 515, Legislative Document 1478, the gentleman from South Portland, Mr. Fuller, now moves that this Bill be assigned for third reading on Wednesday of next week. Is this the pleasure of the House?

The motion prevailed and the Bill with accompanying papers was retabled pending assignment for third reading and specially assigned for Wednesday of next week, April 24.

The SPEAKER: At this time the Chair would like to recognize the presence in the gallery of the House of a group of thirty Girl Scouts from the Town of Bridgton, under the direction of Mrs. Weeman and Mrs. Fessenden. On behalf of the House the Chair extends to you ladies a most cordial welcome and we hope that you will enjoy and profit by your visit with us today. (Applause)

The SPEAKER: The House is proceeding under Orders of the Day.

On motion of the gentleman from Perham, Mr. Bragdon, the House voted to take from the table the seventh tabled and unassigned matter, Bill "An Act relating to Employment of Minors", House Paper 546, Legislative Document 773, tabled on March 19 by that gentleman pending third reading.

The SPEAKER: The Chair recognizes the same gentleman.

Mr. BRAGDON: Mr. Speaker and Members of the House, I now move its indefinite postponement. I oppose this measure because I feel it is a move to further restrict the employment of minors in some of our industries. If you will look at the Bill you will see that in addition to some of the things that are nowThe SPEAKER: The House will be at ease.

House at Ease

Called to order by the Speaker. The gentleman from Bangor, Mr. Totman, was granted unanimous consent to address the House.

Mr. TOTMAN: Mr. Speaker and Members of the House: On April 9 the House passed an order requesting the joint standing Committee on Transportation to make a preliminary survey of representative areas of the State to appraise the advisability of further and more detailed study of the gasoline pricing situation between the gasoline price zones of the State of Maine. I am reporting as House Chairman of the Committee that the Committee held an executive session and it was decided that pending the receipt of further information and in fairness to the gasoline industry, it would request the House for an extension of time and report at the earliest possible moment the exact findings of our preliminary survey.

The SPEAKER: The Chair understands that the gentleman from Bangor, Mr. Totman, as Chairman of the Transportation Committee, requests of the House additional time for that Committee to reach its conclusion in regard to the study just mentioned. Mr. BRAGDON: Mr. Speaker, in view of what has happened, I hardly know what procedure to make, but I would move to retable this matter, I didn't realize it was the Bill of the gentleman from Portland, Mr. Hanscomb, until such time as he is prepared.

The SPEAKER: With respect to item number seven, Bill "An Act relating to Employment of Minors", House Paper 546, Legislative Document 773, the gentleman from Perham, Mr. Bragdon, withdraws his motion and now moves that it be retabled unassigned pending third reading. Is this the pleasure of the House?

The motion prevailed and the Bill was retabled pending third reading unassigned.

Mr. Hilton of Anson out of order and under suspension of the rules, presented the following Order and moved its passage:
