HOUSE

Wednesday, May 7, 1958

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Horace Colpitts of Augusta.

The journal of yesterday was read and approved.

Paper from the Senate Senate Report of Committee Non-Concurrent Matter

Bill "An Act relating to Definition of Fish under Weights and Measures Law" (S. P. 674) which was referred to the Committee on Agriculture in non-concurrence in the House on May 6.

Came from the Senate indefinitely postponed in non-concurrence.

In the House:

STATE OF CONNECTICUT

March Session 1958

Senate Joint Resolution No. 9

RESOLUTION CONCERNING AP-PLICATION TO CONGRESS TO CALL A CONVENTION FOR PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE UNITED STATES.

Resolved by this Assembly:

That pursuant to the provisions of Article V of the Constitution of the United States, the Legislature of the state of Connecticut applies to the Congress to call a convention for the purposes of proposing an amendment to the Constitution of the United States preventing the taxation of the income of the residents of one state by another state.

Be It Further Resolved, That the secretary of the state cause copies of this resolution to be sent to the President of the United States Senate, the Speaker of the United States House of Representatives, and to the respective clerks of the several state legislatures. Certified as correct by
