**SENATE**

Thursday, February 21, 1957

Senate called to order by the President.

Prayer by Rev. Harvey F. Ammerman of Augusta.

On motion by Mr. Parker of Piscataquis, Journal of yesterday read and approved.

**Orders of the Day**

Mr. Sinclair of Somerset was granted unanimous consent to address the Senate.

Mr. SINCLAIR: Mr. President and members of the Senate: I would like to explain my reason for recalling these two resolves, L. D. 3 and L. D. 92. My plan is to table

these two resolves, primarily because they involve a considerable amount of money and I think it would be well if they were tabled for the time being at least until we get a clearer picture of the financial set-up.

I would also like to provide in that motion to table these resolves that these resolves be put on a Special Appropriations Table, and I would like to move that this particular Appropriations Table be not printed every day, which would cost considerable money in addition to adding to our calendar, and suggest that they be printed once a week so that each member of the Senate will know the appropriations bills that are tabled and the reason for their being tabled. I think there is a great deal of merit in keeping our calendar as clean as possible. Because of that, I would include in my motion that we have a Special Calendar. I would also like to have that motion include the right of any other member of the Appropriations Committee, in case I should be ab-

sent, to table a bill that is of the same nature as these two resolves.

The PRESIDENT: The Senator from Somerset, Senator Sinclair, noting that H. P. 63, L. D. 92 "Resolve to Reimburse the Town of Freeport for aid extended to family of Earl S. Williams," and H. P. 4, L. D. 3 "Resolve to Reimburse the Town of Limestone for aid extended to family of Ines Bradley" are in the possession of the Senate, having been recalled from the office of the Governor, now moves that the Senate reconsider its former action whereby these resolves were finally passed.

The motion to reconsider prevailed and on further motion by the same Senator, the resolves were laid upon the Special Table pending final passage.
