SENATE

Wednesday March 13, 1957

Senate called to order by the President.

Prayer by Rev. Ernest B. Johnson of Hallowell.

The PRESIDENT: The notes the return to the Senate Chamber of the Senator from Oxford, Senator Ferguson. On behalf of the Senate, the Chair expresses our deep regret in the death of his father, Kenneth H. Ferguson, who died March 2nd at St. Esprit, Nova Scotia at the age of 97. The Chair expresses its regret that time and distance prevented Senate representation. Our heartfelt sympathy goes to you, "Norm," and we congratulate you for having had your father with you for the long number of years that you did.

On motion by Mr. Woodcock of Penobscot,

The PRESIDENT: The Chair at this time notes the 1957 appearance in our Senate Chamber of a distinguished junior citizen of the State of Maine. The Chair refers to the Governor of 1956 Boys State, Mr. Peter T. Berry of Calais, accompanied by the dean and guiding genius of this very much worthwhile program.

The Chair would request the Assistant Sergeant-at-Arms to escort to the rostrum the Governor of Boys State, Governor Berry, and "Jim" Boyle. (Applause, members rising)

Governor Berry, the gavel and the rostrum are yours, sir.

GOVERNOR OF BOYS STATE, PETER T. BERRY: President Haskell, members of the Senate and guests: It is with great pleasure that I bring to you this morning the welcome of Boys State of the year 1956.

Many of you are no doubt familiar, at least in a small way, with Boys State and what it does in the State of Maine. I would like to bring to you this morning a few of my personal experiences as Governor and then tell you what Boys State really means to a boy of my age.

Many of you probably already know that Boys State is divided up into two parties, a group called the Federalists and a group called the Nationalists. But there is also another minority group which is called the Independents, and I would like to speak briefly this morning about the Independents as I was one of them.

When you arrive at Boys State you are given a card and it tells you to what party you belong. We were a delegated minority numbering only seventy, whereas the other two parties had one hundred and twenty each. So you can understand the policy has always been for the independents to split and join another one of the parties; but, as it appeared this year, the Independents would not split but would remain independent.

Several amusing instances arose while we were there. It was interesting to note that as soon as this became obvious there was much trouble among the other parties; and so we succeeded in serving a portion of the Federalist Party when it became apparent that the Independents did not stand a chance. But our hopes soon dimmed when the Nationalists took part in a little dirty politics. I call it "dirty politics"; probably some of you gentlemen are more familiar with the term. What it really consisted of was that the Nationalist candidate for Governor, in return for the support of the Federalist candidate, offered him the five top governmental appointments. (Laughter) So you can understand that when the election approached it was entirely in the hands of the Federalists, and, as I am here before you today, I just say that fate smiled on me.

The main purpose of Boys State I think is two-fold. One purpose is to enlighten the youth of the State of Maine on the purposes and functions of its government, and, second, to create an atmosphere of good fellowship among upwards of 350 boys in the short space of only one week. How this is done is surely amazing, and I am sure that one of the most important factors is the counselors that Mr. Boyle gathers together each year. They are the

top men in the State and they really are wonderful to all boys present.

Boys State as an example of civics and practice is something unique today. Every effort is made to try to create real situations so that boys can participate in their government so that a boy will learn what he has to do to be a good citizen of tomorrow. This is done with the help of experts in every field of State government, such as your own Secretary of the Senate, Chester Winslow, and Harvey Pease, Clerk of the House. These men all give their valuable time, some of them their vacations, to come down and instruct us in the proper procedures in legislation. We are also deeply indebted to local officials, to town managers and city clerks of the communities, who help us in our town meetings, which are such a valuable part of Boys State. Taking all this into consideration, I am sure you can understand that when a boy leaves Boys State there is a deeper realization of his place in this world today. You suddenly overnight learn how to mingle with people who were entire strangers a week before. We also are richer in knowledge of State government.

Now I would like to take a direct switch. After Boys State I returned to my home in Calais, and as I was selected as one of two delegates to represent Boys State in Washington, D. C. at Boys Nation became all excited about the whole situation. Along with Mr. James Bourassa of Presque Isle, who was the other member, we went to Washington and there had many more interesting experiences.

The purpose of Boys Nation is primarily the same as that of Boys State, except here instead of boys from your own state you are gathered with two boys from every state in the United States, and the attention is not on State and local government but is focussed primarily on the function of the federal government.

Now in Boys Nation there are only two parties, the Nationalists and the Federalists. Of course I immediately lost all desire to run for any office because there were no Independents with whom we could negotiate. But being there I decided I was really

going to like to stay, so in all senses of the word I really stuck it out.

The elections there did not have the interest, not only to me but to the other boys, that they do here, because there our attention is primarily focussed on the construction of the Boys Nation Senate. This functioned as a body and took action on several bills which were presented to us.

Boys Nation is located in College Park, Maryland, the home of the University of Maryland. It is really a beautiful capital and it is really an educational experience, because at all times you are in the shadow of our nation's capital. It is only a ten or fifteen minutes' ride from Washington. It is a wonderful experience to be there. As in Boys State, everything possible is done to create realistic situations in government. It is not to create a political feeling but more to create a political understanding of a boy's obligation to his country and to his home and his state. We combine daily Senate meetings with daily visits to Washington and points of interest thereabouts. It was all very educational and made for a really wonderful experience because we had a very fast-moving schedule.

It was interesting to note that we were passed two bills for our deliberation during our stay there, and one of them was a bill by our own Senator Payne, which concerned the President and his ability to carry on his office. I imagine most of you are familiar with it. It was very hotly debated by the Boys Nation Senate. Of course the recent illness of President Eisenhower made the country all the more aware of the need to properly regulate the President's ability or inability to exercise the duties of his office.

I would like to tell you briefly of a few of the experiences that we had while we were there. One of the most fabulous, I think, was the opportunity to visit the Pentagon and hear on the same program such men as Secretary of Defense Wilson, General Maxwell Taylor of the United States Army, and Admiral Burtt, Chief of Naval Operations of the United States Navy. These gentlemen all spoke to us and were very congenial.

Also I think it is a fitting tribute to the men who have worked so hard for Boys State and Boys Nation to know that on our final day in Washington we were allowed to convene in the old Senate Chamber in the nation's capital. If any of you have visited it you know it is closed to the public, but once a year they open it up and allow Boys Nation to hold their final session there. We held our session and the bill that was presented by Mr. Payne was approved and passed by the Boys Nation Senate.

I think a fitting climax to any boy's life in this period is my final experience and one which I will always remember. We were invited to the White House but we did not think we would be able to see the However, President. it became known that he would visit us briefly, as he had just returned from a long trip the day before and he was still convalescing from his recent illness. In a short time, however, he was among us and mingled with us and shook hands with us all personally. I invited him down for a little hunting and fishing, but with the coming election he decided it would be inadvisable at the time. However, he did say he would drop down. I do not know whether we can expect to see him.

So I think that with this atmosphere that was created by President Eisenhower being among us that every boy left Boys Nation with a new understanding of what was his job in our world of tomorrow.

In closing, I would like to thank you all for your kind attention.

Mr. Winslow, will you please stand up? Mr. Winslow, on behalf of many years service to Boys State I would like to present this brief-case to you and thank you most kindly. (Applause, members rising)
