# Orders of the Day

On motion by Mr. Wyman of Washington, the Senate voted to reconsider its action taken earlier today whereby it passed to be engrossed, Bill, "An Act Relating to the Measuring of Herring." (H. P. 869) (L. D. 1207); and on further motion by the same Senator, the Bill was laid upon the table pending passage to be engrossed.

On motion by Mr. Briggs of Aroostook, the Senate voted to take from the table Bill, "An Act to Create the Bangor Water District," (H. P. 54) (L. D. 70) tabled by that Senator on March 14 pending passage to be enacted.

Mr. BRIGGS of Aroostook: Mr. President and members of the Senate: I wish to address myself briefly to this question this morning. I know that many of you here probably question my judgment on these matters, but few of you, I believe, question my sincerity to make as much progress in this problem as is consistent with objective purposes all around.

This bill which I tabled Friday came about from my position that it is now a great shame that this burden of cost should be placed upon the citizens of Bangor. I know you have heard a great deal in recent sessions about the costs of improving the deplorable condition of our State's public waters. Short shrift is, however, given to costs other than those of pollution abatement, such costs as are related to this act.

It is submitted, as you know, that the citizens of Bangor will appropriate some five millions, estimated, in order to clear out of the Penobscot River, thereby giving it up almost entirely to the industries which are largely responsible for its contamination.

I have given quite a bit of study through the years to the question of water rights. Water being one of our most vital natural resources, this is, as you can understand, a question which has arisen in state after state in our United States right down through the years, and in every one of these cases it has been my finding that the prior and first consideration of water use rights, the legal use of water, has been that which was used for municipal water purposes.

I would like to cite for you a recent Arkansas Supreme Court ruling water rights. The opinion states in part: "When one lawful use of water is destroyed by another lawful use the latter must yield, or it may be enjoined."

The opinion holds further that: "Other than use of water for strict-

ly domestic purposes (which is held superior to other uses) all other lawful uses of water are equal. Some of the lawful uses of water in this state are: fishing, swimming, recreation, industry and irrigation."

I know there has been a lot of causes of contamination of the Penobscot, and I would like to state that the vast majority of that contamination results from the poor housekeeping and poor sanitary waste treatment methods of the industries above this great city.

I would like to read from a recent article in the Bangor Daily News. I am quoting Donald Johnson, who is the superintendent of the water works there. Johnson said: "Chemical wastes in the river from industrial plants in the northern part of the state have produced a dangerous situation." "Furthermore, he said, with large scale expansions planned by several industrial plants to the north, the situation will grow steadily worse."

"Sewage, one of the most common objections to the Penobscot as a source of water, is really no problem," Johnson said. "But the steadily growing presence of chemical wastes in the river presents an almost impossible problem.

I have received an unsolicited letter from a citizen of Bangor, a medical doctor as it happens. I quote:

"We agree with the comments of our local resident, who said: "The Penobscot river is too thick to drink and too thin to plow".

"We have found that by beating it with an egg beater and straining the water that we can remove a good portion of the debris. That makes it almost fit enough to serve to a dog.

It is a most intolerable shame, I think, that the responsibility of water cannot be more equally borne by all of the persons on the various rivers using the water. I want to point out to the members of the Senate that these costs are not being fairly and equally shared. The citi-

zens of Bangor need a municipal sewage treatment plan. No one questions, I believe, that the portion of the municipal waste which is flowing, a good part of it, through the beautiful city, right through the city limits, is something that should be corrected at the earliest possible date.

Now they will be told they cannot afford municipal waste treatment. If they cannot, how can they afford this five million dollars to get out of the Penobscot and give it up to industry. There is no question, I think, but what had this problem of municipal waste treatment been faced squarely a number of years ago that the more equal use of water and the more equal share of the costs of the proper use of this most vital natural resource would be borne more proportionately today.

Several thousand years ago a man named Solomon, reputed to have profound wisdom, built a temple to exalt his ego. To accomplish this he cut down the cedar forests of Lebanon, and in so doing he set in motion the processes of land erosion that have cursed that land up to the present day. Much of the land has been washed away to bed-rock. Multitudes suffer long after the seekers of glory, pomp and power have returned to dust.

I now move the passage of this bill to enactment.

This being an emergency measure, a division of the Senate was had.

Twenty-eight having voted in the affirmative

The bill was passed to be enacted.
