Wednesday, May 8, 1957

Senate called to order by the President.

Prayer by Captain Ash, Salvation Army, Augusta.

On motion by Mr. Silsby of Hancock, Journal of yesterday read and approved.

#### Orders of the Day

Mr. CHARLES of Cumberland: Mr. President, I would like to inquire if we have L. D. 1066 in our possession?

The PRESIDENT: The Chair will apologize to the Senator and ask that the Senate be at ease for two minutes.

#### At Ease

The Senate was called to order by the President.

The PRESIDENT: The Chair will note that bill, "An Act Relating to Death on Duty of Members of Portland Police Department" (H. P. 752) (L. D. 1066) is now in the possession of the Senate, having been recalled by Joint Order presented by Senator Charles of Cumberland.

Thereupon, on motion by Mr. Charles of Cumberland, the Senate voted to reconsider its former action whereby it accepted the Ought not to pass report of the committee; and on further motion by the same Senator, the bill was laid upon the table pending consideration of the Ought not to pass report of the committee.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table Senate Report from the Committee on Constitutional Amendments: Report A, Ought to pass with Committee Amendment A; Report B, Ought to pass in new draft (S. P. 548) (L. D. 1535); Report C, Ought not to pass on "Resolve Proposing an Amendment to the Constitution to Provide for Election of Members of the Executive Council." (S. P. 95) (L. D. 225) tabled by that Senator on April 30 pending motion by Senator Butler of Franklin that the Senate adopt Report C.

The PRESIDENT: The pending question is on the motion of Senator Butler of Franklin, that the Senate adopt Report C.

Mr. WOODCOCK of Penobscot: Mr. President and members of the Senate: This item is the subject of three reports. The present speaker and one other member of this body signed Report "A" with Committee Amendment "A", and in opposition to the pending motion I would like to speak on Report "A" with Committee Amendment "A".

Under the terms of this report. were this bill to become law, the members of the Executive Council would still be seven in number and they would be chosen from each of the now existing Councillor districts of the State, but, in accordance with our Maine statutes, when each individual county became entitled to a councillor it would be the electorate of that county itself and that county alone that would vote upon that councillor. In that way you see counties which are smaller in population would be protected. From those two aspects, the merits of this report I think are manifest, and I would now move that when the vote is taken on the motion that it be by a division.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Franklin, Senator Butler, that the Senate adopt Report C, Ought not to pass, and the Senator from Penobscot, Senator Woodcock, has requested a division.

A division of the Senate was had. None having voted in the affirmative and thirty opposed, the motion did not prevail.

Thereupon, on motion by Mr. Woodcock of Penobscot, Report A was accepted, the bill read once, Committee Amendment A read and adopted and the bill as amended tomorrow assigned for second reading.

On motion by Mr. Lessard of Androscoggin, the Senate voted to take from the table Senate Report from the Committee on Labor: Ought to pass with Committee Amendment A on bill, "An Act Relating to Petition for Review of Incapacity Under Workmen's Compensation Act" (S. P. 162) (L. D. 409) tabled by that Senator on May 7 pending consideration; and on further motion by the same Senator, the bill was recommitted to the Committee on Labor in concurrence.

On motion by Mr. Lessard of Androscoggin, the Senate voted to take from the table Senate Report from the Committee on Public Utilities: Ought to pass with Com-mittee Amendment A, on bill, "An Act Relating to Operation of Diesel or Diesel-Electric Locomotives in Reverse." (S. P. 389) (L. D. 1085) tabled by that Senator on April 16 pending consideration of the report: and on further motion by the same Senator, the Ought to pass report was accepted, the bill read once, Committee Amendment A read and adopted, and the bill as amended tomorrow assigned for second reading.

On motion by Mr. Cole of Waldo, the Senate voted to take from the table House Report from the Committee on Transportation: Leave to Withdraw, on bill, "An Act Relating to Liability Policy for Applicants for Motor Vehicle Dealer or Transit Registration Plates." (H. P. 632) (L. D. 931) tabled by that Senator on March 28 pending consideration of the report; and on further motion by the same Senator, the Leave to Withdraw report was accepted in concurrence.

On motion by Mr. Low of Knox, the Senate voted to take from the table bill, "An Act to Exclude Town of Cooper, Washington County, from Maine Forestry District." (H. P. 821) (L. D. 1517) tabled by that Senator on May 7 pending motion by Senator Wyman of Washington that the Senate adopt Senate Amendment A; and that Senator moves the pending question.

Thereupon, Senate Amendment A was adopted and the bill as amended by Senate Amendment A was passed to be engrossed in nonconcurrence.

Sent down for concurrence.

Mr. CHARLES of Cumberland: Mr. President, I would like to inquire if the Senator from Franklin,

Senator Butler has any objection to the removal of Item 73 from the table?

The PRESIDENT: The Senator from Franklin, Senator Butler did advise the Chair that he would be pleased if the Senator from Cumberland, Senator Charles did move to take Item 73 from the table and so the Chair lays before the Senate, bill, "An Act Relating to the Operation of Bicycles," (H. P. 1062) (L. D. 1517) tabled on May 7 by the Senator from Franklin, Senator Butler, pending passage to be enacted.

Thereupon, on motion by Mr. Charles of Cumberland, the rules were suspended and the Senate voted to reconsider its former action whereby the bill was passed to be engrossed and the same Senator presented Senate Amendment A and moved its adoption.

Which amendment was read and adopted and the bill as amended passed to be engrossed in nonconcurrence.

Sent down for concurrence.

On motion by Mr. Lessard of Androscoggin, the Senate voted to take from the table bill, "An Act Repealing Law Prohibiting Riding with a Naked Scythe." (H. P. 454) (L. D. 629) tabled by that Senator on March 27 pending assignment for second reading; and on further motion by the same Senator, the bill was tomorrow assigned for second reading.

The PRESIDENT: The Chair would note that as the adjournment without day approaches, it can be difficult to have tabled matters which the Senate hopes to pass, still on the table pending consideration committee reports. The Chair of would point out that until such time as reports have been accepted and bills passed to be engrossed in concurrence, the work of the engrossing department cannot be completed and almost without exception, it is the engrossing of these bills that holds us here into unholy hours which is a situation to be avoided. The Chair would point out that if there are ought to pass reports which must be accepted in concurrence, they should at least have that concurrence and be engrossed.

On motion by Mr. Curtis of Cumberland, the Senate voted to take from the table Senate Report from the Committee on State Government: Ought to Pass, on bill, "An Act Establishing Minimum Wages of Employees in Public Works by State of Maine." (S. P. 424) (L. D. 1183) tabled by that Senator on May 7 pending consideration of the report.

Mr. CURTIS of Cumberland: Mr. President and members of the Senate: Thank you very much for extending me the courtesy of tabling this measure as I was away yesterday.

This is an act establishing minimum wages for employees in public works in the State of Maine, and it is simply an attempt to bring Maine under the same kind of regulation which applies to interstate or national business. It is an attempt to regulate the construction business in the State as it pertains State highways or municipal to works, anything to do with State building. We endeavored to write a bill which would take the labor forces out of the competitive market. As you know, almost all contracts are let by bids, and in some cases there have been abuses of labor by taking the wages paid and lowering them and forcing a situation whereby the job was won by a contractor and the difference really came out of his workers. The bill received a unanimous "Ought not to pass" report from the committee. I am sure they gave it due deliberation in considering it. I am rather sorry that they came out that way, and so at the present time I would move to substitute the bill for the committee report.

The PRESIDENT: The Senator from Cumberland, Senator Curtis, moves that the bill be substituted for the "Ought not to pass" report of the committee.

Mr. ROGERSON of Aroostook: Mr. President, in support of the position taken by the Committee on State Government which heard this bill, I should like to say that this bill was presented to the committee as a little Davis-Bacon Act. For those of you who are not acquainted with the Davis-Bacon Act, I might say that this is an act which was designed to correct a situation in northern New York State some years ago when a construction project was going on and a contractor imported into the area low-priced southern help and paid them wages which were far below the wages existing in that area, and as a result was criticised a great deal for it, to the extent that eventually the Davis-Bacon Act was passed to prevent that sort of thing from happening.

This bill is designed to do the same, I understand, but I would like to point out that at the present time there is so much construction work going on in the State that wages are high and there seems to be very little need for protection of this sort.

There were other things which the committee did not like about the bill. In the first place it is ambiguous. I should like to quote the last paragraph of Section 51-A, in which it says: "If, in any of the area where the works are to be constructed, a wage rate or wage rates have been established in certain trades and occupations by collective agreements or understandings between organized labor and employers, the rate or rates to be paid on said works shall not be less than the rates so established."

In other words, if a highway were to be built in the vicinity of Loring Air Base the wages which would have to be paid under this bill to people employed by the contractor would have to be at least as high as the wages which had been arrived at by negotiation between labor and industry. The word "area" is not defined in the bill; we do not know whether it would be within ten miles or fifty miles or whether it would take in the whole state. I understand there has been a ruling in a similar situation where the word "locality" has been interpreted to take in not only the state but the entire nation. Basically, I think the committee's feeling was that the legislation was not needed and that seemed to be enough justification for a unanimous "Ought not to pass" report, and I hope, of course, that the motion of the Senator from Cumberland, Senator Curtis, does not prevail.

Mr. BOUCHER of Androscoggin: Mr. President, I am reluctant to take part in this discussion, but as an employer and a contractor I feel

it is a very good bill. I have had occasion to bid on work for the federal government, and they request that contractors pay the prevailing wages in that neighborhood. I think this bill is similar. I think it is a protection to people employed in the State of Maine, for them to get fair compensation for the work that they do. I do not feel that the State or the cities and towns should be able to employ people at a lower rate than we as contractors do in a certain field. I feel that to be honest the State should pay wages similar to what are paid to the different tradesmen in that neighborhood. I am all for the bill and I hope that the Senate will favor the motion of the Senator from Cumberland, Senator Curtis. I really feel it is a very important bill and a fair bill.

Mr. SINCLAIR of Somerset: Mr. President and members of the Senate: I rise in opposition to the motion of the Senator from Cumberland, Senator Curtis. I do not believe that we need this type of legislation in the State of Maine today. I have had considerable ex-perience with the Davis-Bacon Act and I know that "prevailing wages" are not usually the wages prevailing in the area. I think it would do a great deal of harm. I think it would cost the State a great deal of money, and I shall not support the motion of the Senator from Cumberland, Senator Curtis, but shall go along with the unanimous "Ought not to pass" report of the committee.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Curtis, that the Senate substitute the bill for the "Ought not to pass" report of the committee. A viva voce vote being taken, the motion did not prevail.

Thereupon, on motion by Mr. Rogerson of Aroostook, the "Ought not to pass" report of the committee was accepted.

Sent down for concurrence.

On motion by Mr. Briggs of Aroostook,

Recessed to the sound of the gavel.

The Senate was called to order by the President.

On motion by Mr. Briggs of Aroostook, the Senate voted to take from the table Senate Report from the Committee on Appropriations and Financial Affairs: "Ought not to pass" on "Resolve Establishing a Theodore Roosevelt Centennial Commission of Maine." (S. P. 62) (L. D. 112) tabled by that Senator earlier in today's session pending consideration of the report.

Mr. BRIGGS of Aroostook: Mr. President and Members of the Senate, I have conferred with the Chairman of the Appropriations Committee and we feel that we can get together and return this bill to the committee and do proper honor to this great American and our state. I move that the resolve be recommitted to the Committee.

The motion prevailed and the bill and the Ought not to pass report of the committee was referred to the Committee on Appropriations and Financial Affairs.

Sent down for concurrence.

On motion by Mr. Briggs of Aroostook

Adjourned until tomorrow morning at ten o'clock.
