LD 32 / HP0028

An Act Pertaining to Employment of Minors in Hotels and Motels. Presented by Rep. Kiesman of Fryeburg; Co-sponsored by Rep. Hutchings of Lincolnville. Labor Hearing 1-21-81. Majority O.N.T.P. Accepted by House; Minority OTP-AM Accepted by Senate. In House - Adhere to Majority Report; In Senate - Engrossed as Amended. Died Between Houses.
