LD 162 / HP0135

An Act to Permit Appointment of Deputies for the Purpose of Registering Voters Under the Election Laws. Presented by Rep. Baker of Portland; Co-sponsored by Rep. Soulas of Bangor, Rep. Manning of Portland, Rep. Berube of Lewiston. Election Laws Hearing 2-10-81. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-363, HB/CA H-417. In House - Adhered to Engrossed with CA and HB; In Senate - Adhered to Indefinite Postponement. Died Between Houses
