LD 264 / HP0227

An Act to Allow Municipalities the Option of Charging Reasonable Service Charges on Certain Tax Exempt Property. Presented by Rep. Brenerman of Portland; Co-sponsored by Rep. Aloupis of Bangor, Rep. Gillis of Calais, Rep. Murphy of Kennebunk. Taxation Hearing 2-25-81. Majority OTP-ND (HP1459 / LD 1598) Accepted by House; Minority O.N.T.P. Accepted by Senate. In House - Indefinitely Postponed; In Senate - Minority (O.N.T.P.) Report Accepted. Died Between Houses.
