An Act Providing Collective Bargaining Rights to Legislative Employees. Presented by Rep. Baker of Portland; Co-sponsored by Rep. Davies of Orono. Labor Hearing 2-25-81. (House Accepted OTP-AM) (O.N.T.P.) (Senate Accepted OTP-AM). In House - Adhered to Report A; In Senate - Adhered to Engrossing with CB. Died Between Houses.
