Resolve, Providing for Revision to the Land Use Regulation Commission's Land Use Handbook, Section 6, "Erosion Control on Logging Jobs." Presented by Rep. Hall of Sangerville. Energy & Natural Resources Hearing 2-23-81. Majority O.T.P. Accepted by House; Minority OTP-AM Accepted by Senate. In House - Adhered to Conference Committee; In Senate - Adhered to Engrossing with CA. Died Between Houses.
