LD 561 / HP0510

An Act to Retain the Motor Vehicle Operator License and Examination Fees and Motor Vehicle Title Fees Currently in Effect. Presented by Rep. Carroll of Limerick; Co-sponsored by Sen. Usher of Cumberland. Transportation Hearing 2-11-81. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA H-32. In House - Failed Emerg. Enactment; In Senate - Failed Enactment. Died Between Houses.
