An Act Authorizing Reasonable Fees for Nonresident Users of Public Libraries. Presented by Rep. Beaulieu of Portland; Co-sponsored by Sen. Najarian of Cumberland, Sen. Devoe of Penobscot, Rep. Lund of Augusta. Education Hearing 2-25-81. OTP-AM Accepted. Amended by: CA H-415. In House - Adhered to Enactment; In Senate - Indefinitely Postponed. Died Between Houses.
