An Act to Clarify Certain Provisions of Law Relating to the Method of Voting for School Committee Members of the Wells-Ogunquit Community School District. Presented by Rep. Wentworth of Wells; Co-sponsored by Sen. Hichens of York, Rep. Gowen of Standish, Sen. Wood of York. Local & County Government Hearing 4-23-81. (House Accepted O.T.P.) (OTP-ND: HP1529 / LD 1635) (OTP-AM). In House - Adhered to Engrossing with HA; In Senate - Adhered to Indefinite Postponement. Died Between Houses.
