LD 709 / HP0626

An Act to Increase Eligibility Levels for the Elderly Householders Tax and Rent Refund Act. Presented by Rep. Hayden of Durham; Co-sponsored by Sen. Emerson of Penobscot, Rep. Post of Owls Head, Sen. Clark of Cumberland. Taxation Hearing 2-20-81. OTP-AM Accepted. Amended by: CA H-495. Indefinitely Postponed. Pursuant to Joint Order (SP 727), recalled from the Legislative Files. Enacted, Approved 12-17-81, PUBLIC LAWS, Chapt. 535.

Joint Order, That "An Act to Increase Eligibility Levels for the Elderly Householders Tax and Rent Refund Act" (HP 626) (LD 709) be recalled from the legislative files to the Senate. Presented by Sen. Ault of Kennebec; Co-sponsored by Sen. McBreairty of Aroostook, Rep. Tarbell of Bangor, Rep. Paradis of Old Town. Passed in Concurrence 12-9-81.
