LD 789 / SP0281

An Act to Place a Maximum Limit on the Inflation Adjustment under the Workers' Compensation Act. Presented by Sen. Sutton of Oxford; Co-sponsored by Sen. Brown of Washington, Rep. Soule of Westport, Rep. Tarbell of Bangor. Labor Hearing 3-11-81. Majority OTP-AM Accepted by House; Minority O.T.P. Accepted by Senate. In House - Adhered to Indefinite Postponement; In Senate - Engrossed as Amended. Died Between Houses.
