LD 977 / HP0863

An Act to Repeal the Termination Date of the Emergency Petroleum Products Supply Act. Presented by Rep. Martin of Eagle Lake; Co-sponsored by Sen. Pray of Penobscot, Sen. Collins of Knox, Rep. Huber of Falmouth. Business Legislation Hearing 3-9-81. Majority OTP-AM Accepted by House; Minority O.N.T.P. Accepted by Senate. In House - Adhered to Engrossing as Amended by CA; In Senate - Adhered to Minority Report. Died Between Houses.
