LD 979 / HP0823

An Act Providing Collective Bargaining Rights to Judicial Employees. Presented by Rep. Hobbins of Saco; Co-sponsored by Rep. Beaulieu of Portland, Rep. McHenry of Madawaska. Labor Hearing 3-30-81. (House Accepted O.T.P.) (O.N.T.P.) (Senate Accepted OTP-AM). In Houses - Adhered to Engrossing; In Senate - Adhered to Engrossing with CA. Died Between Houses.
