History and Final Disposition

LD 1061 / SP0362 (ND 1594 / SP0598)

An Act to Clarify the Status of Certain Real Estate Titles in the State. Presented by Sen. Sewall of Lincoln. Judiciary Hearing 3-24-81. Majority OTP-ND Accepted (Minority O.N.T.P.). NEW DRAFT: SP0598 / LD 1594. Amended by: HA H-573. Enacted. This bill was neither signed nor vetoed by the Governor. Recalled from the Governor's Desk pursuant to SP 725. Indefinitely Postponed.

HP1694

Joint Order, That the Joint Standing Committee on Judiciary shall study the provisions of LD 1594 and shall develop a procedure which may be used to determine what lands or parts of lands are covered by the provision of that Bill and which will protect owners of such lands, future purchasers of such lands, title attorneys and the State by making it possible to determine if particular lands are covered by that Bill. Presented by Rep. Hobbins of Saco; Co-sponsored by Rep. Livesay of Brunswick. Passed in Concurrence 6-11-81.

SP0725

Joint Order, That Bill "An Act to Clarify the Status of Certain Real Estate Titles in the State" (SP 598) (LD 1594) be recalled from the Governor's desk to the Senate. Presented by Sen. Devoe of Penobscot. Passed in Concurrence 9-25-81.
