LD 1121 / HP0945 (ND 1663 / HP1550)

An Act to Authorize a Bond Issue in the Amount of \$4,800,000 for Energy Conservation Improvements for State-owned Buildings, Completion of State of Maine Park Facilities and Improvements to Airports in the State of Maine. Presented by Rep. Huber of Falmouth; Co-sponsored by Rep. Beaulieu of Portland, Sen. Dutremble of York, Sen. Trotzky of Penobscot. Appropriations & Financial Affairs Hearing 4-9-81. Majority OTP-ND Accepted (Minority OTP-ND HP1551 / LD 1664). NEW DRAFT: HP1550 / LD 1663, FIRST NEW TITLE: An Act to Authorize Bond Issues up to the Amount of \$5,100,000 for Energy Conservation Improvements for State-owned Buildings, Completion of State of Maine Park Facilities and Equipment Replacement for the Maine Public Broadcasting Network in the State of Maine. SECOND NEW TITLE: An Act to Authorize Bond Issues up to the Amount of \$4,100,000 for Energy Conservation Improvements for State-owned Buildings, Completion of State of Maine Park Facilities and Equipment Replacement for the Maine Public Broadcasting Network in the State of Maine. Amended by: HA H-528, SA (Changed Title) S-364. Enacted, Approved 6-23-81, P AND S LAWS, Chapt. 64. First question (energy conservation improvements) approved in referendum, 11-3-81 (In favor: 133,514; Opposed: 99,251); second question (development of state park facilities) failed in referendum, 11-3-81 (In favor: 113,118; Opposed: 119,900); third question (Maine Public Broadcasting Network) failed in referendum, 11-3-81 (In favor: 111,575; Opposed: 119,603).
