LD 1135 / SP0377

An Act to Limit the Amount of State Expenditures which may be made from Undedicated Revenues without Voter Approval. Presented by Sen. Huber of Cumberland. Appropriations & Financial Affairs Hearing 4-22-81. Majority OTP-AM Accepted by Senate; Minority OTP-AM. In House - Adhered to Indefinite Postponement; in Senate - Adhered to Engrossed with CA. Died Between Houses.
