An Act to Remove the Customer Charge from Electric Utility Rate Structures. Presented by Sen. Trafton of Androscoggin; Co-sponsored by Sen. Hichens of York, Rep. Connolly of Portland, Rep. Gowen of Standish. Public Utilities Hearing 4-16-81. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA S-245. Enactment Failed.
