LD 1259 / HP1040

An Act to Provide a Referendum to Abolish County Government and Authorize Reassignment of its Functions and Duties to Appropriate State and Municipal Departments and Agencies. Presented by Rep. Carter of Winslow; Co-sponsored by Rep. Martin of Eagle Lake, Rep. Hall of Sangerville, Sen. McBreairty of Aroostook. Local & County Government Hearing 4-14-81. Majority O.N.T.P. Accepted by Senate; Minority O.T.P. Accepted by House. This Bill Died in a Committee of Conference.
