An Act to Provide Loans for Family Farms. Presented by Sen. Wood of York. Agriculture Hearing 4-23-81. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA S-170. In House - Engrossed as Amended; In Senate - Adhered to Indefinite Postponement. Died Between Houses.
