History and Final Disposition

LD 1424 / HP1209

An Act to Create a Maine Film Board. Presented by Rep. Higgins of Portland; Co-sponsored by Rep. Nelson of Portland, Rep. Michael of Auburn, Sen. Najarian of Cumberland. State Government. Majority OTP-AM Accepted (Minority O.N.T.P.). In House - Insisted on Engrossing with CA; In Senate - Adhered to Minority Report. Died Between Houses.
