SP0600

Joint Order, That the Joint Standing Committee on Health and Institutional Services report out a bill to the Senate to require the Department of Human Services to provide home based care as an alternative to nursing home care. Presented by Sen. Gill of Cumberland; Co-sponsored by Rep. Prescott of Hampden. Passed in Concurrence 5-13-81. (See LD 1620)
