LD 1660 / HP1543 (ND 2065 / HP2179)

An Act Relating to Informed Consent and Determination of Best Interest for those Unable to Give Informed Consent for Sterilization. Presented by Rep. Connolly of Portland; Co-sponsored by Rep. Benoit of So. Portland. Judiciary Hearing 6-2-81. Pursuant to Joint Order SP 692, this Bill was retained by the committee until the Second Regular Session. Judiciary Hearing 2-24-82. Majority OTP-ND Accepted (Minority O.N.T.P.). NEW DRAFT: HP2179 / LD 2065. Amended by: HA H-650. Enacted, Approved 4-1-82, PUBLIC LAWS, Chapt. 621.
