Joint Order, That a committee shall study the retirement provisions contained in LD 1683 to determine if the funding is sound and to make recommendations for corrective action if remedial action is required. Presented by Sen. Teague of Somerset; Co-sponsored by Sen. Perkins of Hancock, Rep. Nelson of Portland, Rep. Pearson of Old Town. Passed in Concurrence 6-19-81.
