LD 1693 / SP0714

An Act to Amend a Bond Issue to Increase the Amount by \$5,000,000 and to Provide Authority to Construct, Acquire or Improve Drydocks and Other Ship Construction and Repair Facilities. Presented by Sen. Conley of Cumberland; Co-sponsored by Rep. Higgins of Scarborough, Rep. Martin of Eagle Lake. Transportation Hearing 7-31-81. O.T.P. Accepted. Enacted, Approved 8-3-81, P AND S LAWS, Chapt. 75. Approved as amended in Referendum, 11-3-81 (In favor: 134,261; Opposed: 100,840).
