An Act Providing for Conformity with the United States Internal Revenue Code as of December 1, 1981. Presented by Rep. Martin of Eagle Lake; Co-sponsored by Sen. Conley of Cumberland, Rep. Higgins of Scarborough, Sen. Sewall of Penobscot. Taxation. O.T.P. Accepted (OTP-AM) (O.N.T.P.). Emerg. Enacted, Approved 12-17-81, PUBLIC LAWS, Chapt. 536.
