An Act to Adjust Annually Individual Income Tax Laws to Eliminate Inflation-induced Increases in Individual State Income Taxes. Taxation Hearing 3-5-82. Majority O.N.T.P. Accepted by Senate; Minority O.T.P. Accepted by House. In House - Adhere to Engrossing. Died Between Houses. Approved in Referendum, 11-2-82 (In favor: 240,023; Opposed: 182,939). INITIATED BILL, Chapt. 2.
