Original Title: Resolution, Proposing an Amendment to the Constitution of Maine Prohibiting Bond Issues of Less than \$2,000,000. New Title: An Act Prohibiting Bond Issues of Less than \$2,000,000. Presented by Rep. Jalbert of Lewiston. State Government Hearing 1-27-82. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA (Changed Title) H-597. In House - Failed Enactment; In Senate - Indefinitely Postponed. Died Between Houses.
