Majority OTP-ND Accepted (Minority OTP-ND: HP2240 / LD 2099). NEW DRAFT: HP2239 / LD 2098. Amended by: HA H-695, HB H-696, SB S-457, SC S-458, SD/HA S-461. In House - Enacted; In Senate - Referred to Appropriations & Financial Affairs Committee. Died Between Houses. (Cf. LD 2146)
