An Act to Amend the Maine Medical Compact. Presented by Sen. Hichens of York; Co-sponsored by Sen. Pierce of Kennebec, Rep. McPherson of Eliot, Rep. Rolde of York. Education Re-referred to Appropriations & Financial Affairs Hearing 3-9-82. OTP-AM Accepted. Amended by: CA S-416. In House - Enacted; In Senate - Referred to Appropriations & Financial Affairs Committee. Died Between Houses. (Cf. LD 2145, Pt. D)
