Original Title: An Act to Require Mandatory Reporting of Elderly Abuse. New Title: An Act to Require Reporting of Abuse of Elderly or Incapacitated Adults. Presented by Sen. Conley of Cumberland; Co-sponsored by Sen. O'Leary of Oxford, Rep. Diamond of Bangor, Rep. Nelson of Portland. Health & Institutional Services Hearing 2-9-82. Majority OTP-AM Accepted (Minority OTP-AM). Amended by: CA (Changed Title) S-414, SA/CA (Changed Title) S-433. In House - Enacted; In Senate - Referred to Appropriations & Financial Affairs Committee. Died Between Houses. (Cf LD 2145, Pt. E)
