An Act to Revise the Procedure for Municipalities Withdrawing from the Maine Forestry District. (Reported pursuant to Study Order.) Taxation Hearing 2-11-82. OTP-AM Accepted. Amended by: CA H-707. In House - Enacted; In Senate - Referred to Appropriations & Financial Affairs Committee. Died Between Houses. (Cf. LD 2145, Pt. H)
